WHEREAS, In 1955, Mr. Merriman joined the family business, Merriman's Fine Foods in Amarillo, and following in his father's footsteps, he went on to become the company's owner; he moved the store to Wolflin Square, where its popularity grew among area residents, and he always emphasized to his employees the importance of treating their customers well; and

WHEREAS, Mr. Merriman's devout faith eventually inspired him to close the business to pursue a full-time career in the ministry; he was ordained into the Evangelical Presbyterian Church and subsequently served in various capacities with different fellowships; he and his wife lived for a time in Estes Park, Colorado, where he owned a bookstore, continued his ministry, and
