1           WHEREAS, The city of Richwood lost a beloved resident with  
2 the death of former mayor and city councilman David Allen Head on  
3 March 3, 2019, at the age of 80; and

4           WHEREAS, David Head was born in Waco on September 27, 1938, to  
5 David Rankin Head and Dixie Corine Head, and he grew up with a  
6 sister, Sally; following his graduation from Waco High School in  
7 1957, he took a job with the Dow Chemical Company and relocated to  
8 Lake Jackson; and

9           WHEREAS, After later settling in Richwood, Mr. Head opened  
10 his own business, David's Food Mart; he received a gunshot wound  
11 during a store robbery, but he recovered and worked for another 30  
12 years in the crane rental business; a leader in his community, he  
13 served his fellow citizens as mayor of Richwood and as a member of  
14 the city council, and he went on to hold the office of Brazoria  
15 County commissioner for Precinct 1; and

16           WHEREAS, In all his endeavors, Mr. Head enjoyed the love and  
17 support of his wife, the former Patricia Lynn Streetman, and the  
18 couple shared a rewarding marriage that spanned nearly half a  
19 century before Mrs. Head's passing in 2010; he took great pride in  
20 their three children, Cindy, Keith, and Shelley, and through the  
21 years, he was further blessed with six grandchildren, Lindsey,  
22 Josh, Amber, Ashlyn, Caitlyn, and Kylie, and five  
23 great-grandchildren, Mason, Brooklyn, Jayse, Johnsie, and  
24 Koraline; in his leisure hours, he loved to work with his hands, and

1 he spent much of his free time in his garage, doing everything from  
2 making dining room tables to rebuilding engines; and

3 WHEREAS, A devoted family man and a dedicated public servant,  
4 David Head lived a rich and purposeful life, and the memory of his  
5 warmth, his keen wit, and his can-do spirit will forever be  
6 treasured by all those who were fortunate enough to know him; now,  
7 therefore, be it

8 RESOLVED, That the House of Representatives of the 86th Texas  
9 Legislature hereby pay tribute to the life of David Allen Head and  
10 extend heartfelt sympathy to his relatives and many friends; and,  
11 be it further

12 RESOLVED, That an official copy of this resolution be  
13 prepared for his family and that when the Texas House of  
14 Representatives adjourns this day, it do so in memory of David Allen  
15 Head.
