11 WHEREAS, Since 1999, Mr. Murray has served as president and

12 CEO of Peterson Health, and under his leadership, the institution

13 has initiated a medical air transport service and established an

14 ambulatory care center, a women's health center, an acute

15 rehabilitation unit, a clinic in Boerne, and a community care

16 clinic; moreover, in 2008, the 124-bed, 35-acre Peterson Regional

17 Medical Center was opened; Mr. Murray also played an instrumental

18 role in the expansion of Peterson Health's coverage to include

19 Kerr, Kimble, Bandera, and Real Counties, with secondary coverage

20 in Gillespie and Kendall Counties; and

21 WHEREAS, Thanks to his efforts, PRMC has been rated a top 20

22 Rural Community Hospital by the National Rural Health Association,

23 and Peterson Health has earned the Legacy Award from the Kerrville

- 6 found time to give back to his community as president of the Rotary
- 7 Club and the Kerr County United Way board and as chair of the

- 10 is an elder of First Presbyterian Church; and
