6 children under 14 years of age; many drowning and near-drowning

7 accidents can be prevented by following basic safety measures such

8 as supervising children when they are in or around water, learning

9 CPR and first aid, having youths wear life jackets, and enrolling

10 young children in formal swimming lessons, which can help protect

11 them from drowning by as much as 88 percent; and

12 WHEREAS, The Texas Drowning Prevention Alliance and its

partners are setting aside a week to help raise public awareness

14 about the importance of water safety and to reinforce education

15 among those who operate and oversee swimming pools, water

16 playgrounds, hot tubs, and other venues; Drowning Awareness Week

17 serves as an opportunity for Texas families who have been impacted

18 by drowning to share personal stories and to memorialize victims of

19 drowning and for water safety advocates to conduct educational

20 outreach aimed at preventing future tragedies; and

23 attention on the steps that can be taken to promote safety around
