WHEREAS, The son of Leroy Nagel and Jessie Lemburg, "Ted" 4 5 Nagel was born on April 20, 1938, in Houston, and growing up, he enjoyed the companionship of his twin brother, William, and his 6 7 sister, Betty; after graduating from Lamar High School, he studied at The University of Texas at Austin and Sam Houston State 8 University and earned his degree from the University of Houston; he 9 served as a supply sergeant for six years in the United States Army 10 11 Reserve and was honorably discharged on December 31, 1966; and

12 WHEREAS, Mr. Nagel joined the family business, Gibraltar Fence Co., as vice president of operations in August 1960; he went 13 14 on to sell his interest in the company and acquired interest in Nagel Manufacturing and Supply, which made wire and wood hangers 15 for various industries; he was instrumental in establishing Nagel 16 Wire Corporation in 1972, and he retired as president and chair of 17 the board in 2002; active in his industry, he was a lifetime member 18 of the Wire Association International and the Texas Laundry and Dry 19 20 Cleaning Association; and

21 WHEREAS, A devoted family man, Mr. Nagel married Harriet 22 Olsen, a fellow UT student, on November 5, 1960; they were the 23 loving parents of four children, Fred, Jennifer, Laurie, and 24 Elizabeth, and he later experienced the joy of welcoming into his

5 WHEREAS, Mr. Nagel was a founding member of the UMLAUF Sculpture Garden & Museum, a founding director of the Austin 6 Endowment Society, and a member of the German-Texan Heritage 7 8 Society, the Texas State Historical Association, and the Texas Map Society; he also benefited numerous other organizations through his 9 10 involvement, and he notably served for 43 years on the board of directors of Rodeo Austin; a proud fifth-generation Texan, he had a 11 12 great passion for history and also enjoyed geography, hunting, golf, skiing, gardening, ranching, traveling, and watching 13 14 football; and

15 WHEREAS, Ted Nagel left a lasting imprint on the world 16 through his personal and professional achievements, and he will 17 forever be a source of inspiration to those who held him dear; now, 18 therefore, be it
