- 1 WHEREAS, A full and generous life has drawn to a close with
- 2 the death of veteran West Texas aviator Wilson Connell Edwards Sr.
- 3 on May 3, 2019, at the age of 85; and
- WHEREAS, Connie Edwards was born in Big Spring on April 25,
- 5 1934; after completing his education, he earned a pilot's license
- 6 and joined the Army National Guard in 1951, serving throughout the
- 7 Caribbean, Central America, and the United States over the next
- 8 nine years; in 1954, he and his brother, W. P. "Budo" Edwards,
- 9 established the Edwards Petroleum Company, and in 1959, the
- 10 brothers took over their family's ranching and petroleum operations
- 11 in Howard and Glasscock Counties; and
- WHEREAS, In the late 1960s, Mr. Edwards was chief stunt pilot
- 13 for the movie Battle of Britain, flying a variety of World War II
- 14 military aircraft; during filming, he belly-landed a burning
- 15 Spitfire fighter plane with no injuries to himself or others,
- 16 earning a commendation from the Royal Air Force; he owned several
- 17 vintage aircraft, including a TBM Avenger torpedo bomber that
- 18 appeared in the films Close Encounters of the Third Kind and Bermuda
- 19 Triangle; and
- WHEREAS, Mr. Edwards was a member of the Aircraft Owners and
- 21 Pilots Association and president of the Big Spring chapter of the
- 22 Air Force Association; he also served as accident prevention
- 23 counselor for the Lubbock district of the Federal Aviation
- 24 Administration and the U.S. Department of Transportation; in

- 1 addition, he was a director of State National Bank, and he cofounded
- 2 TexaStone Quarries; and
- 3 WHEREAS, This distinguished pilot earned many awards over the
- 4 years, including the Meritorious Service Award from the U.S. Navy,
- 5 the FAA Special Recognition Award, the President's Pilot Award, the
- 6 John Henry Towers Award from the Naval Aviation Commandery, the
- 7 Seaplane Pilot of the Year Award from the Seaplane Pilots
- 8 Association, and honorary wings from the U.S. Coast Guard and the
- 9 air forces of Britain, Spain, Canada, and Portugal; in 2016, he was
- 10 inducted into the Texas Aviation Hall of Fame; and
- 11 WHEREAS, In all his endeavors, Mr. Edwards enjoyed the love
- 12 and support of his wife, Brenda, and he was the proud father of
- 13 three children, Patricia, Nicholas, and the late Wilson C. "Tex"
- 14 Edwards; he was also devoted to his two stepdaughters, Stefanie and
- 15 Tonya, and his eight grandchildren, Andrew, Blake, Haylee, Daniel,
- 16 Emilee, Seth, Wilson, and Aislin; and
- 17 WHEREAS, Connie Edwards brought joy to innumerable people
- 18 through his warmth, wonderful sense of humor, and trove of amazing
- 19 stories, and his spirit of adventure will remain a source of
- 20 inspiration to all who were privileged to know him; now, therefore,
- 21 be it
