1 WHEREAS, Casey Walterscheid of the U.S. Air Force, commander
2 of the 19th Contracting Squadron at Little Rock Air Force Base in
3 Arkansas, was promoted from major to lieutenant colonel on April 1,
4 2019; and

5 WHEREAS, Lieutenant Colonel Walterscheid attended Muenster
6 High School and entered the Air Force in 2004 as a Texas Christian
7 University ROTC graduate; he has fulfilled numerous assignments,
8 including at Brooks City-Base, Tinker Air Force Base, and Joint
9 Base Langley-Eustis; and

10 WHEREAS, Serving as commander of the Defense Contract
11 Management Agency, he held his first command assignment at the
12 Rolls-Royce Corporation in Indianapolis; over the course of his
13 career, he has deployed three times in support of contingency
14 operations in Iraq, Africa, and Afghanistan; and

15 WHEREAS, Currently, Lieutenant Colonel Walterscheid heads up
16 the 19th Contracting Squadron, which purchases commodities,
17 services, and construction projects in support of flying operations
18 at Little Rock AFB, the Air Force's largest and premier C-130 base;
19 his squadron plays a vital role in providing acquisition support to
20 more than 7,000 active duty and reserve personnel and over 39,000
21 dependents and retirees on the base; additionally, he oversees
22 procurement integrity for nearly 2,500 contract actions, and he
23 manages a vendor portfolio of close to 2,000 businesses; he is also
24 responsible for the training of contingency contracting personnel

1 who deploy in support of humanitarian efforts around the globe; and

2 WHEREAS, This summer, Lieutenant Colonel Walterscheid and
3 his family will move to Washington, D.C., where he will join the
4 contracting staff of the U.S. Air Force Secretary at the Pentagon;

6 WHEREAS, Through his exceptional leadership, valor, and
7 devotion to duty, Lieutenant Colonel Casey Walterscheid continues
8 to fulfill the highest ideals of the U.S. armed forces, and he may
9 indeed reflect with pride on his accomplishments as he embarks on
10 the next exciting chapter of his career; now, therefore, be it
