RESOLUTION

- 1 WHEREAS, Suicide is a complex and multifaceted problem, and
- 2 its increasing incidence among certain vulnerable groups,
- 3 including youth and veterans, has become an urgent health care
- 4 priority; and
- 5 WHEREAS, According to the Centers for Disease Control and
- 6 Prevention, the national suicide rate for teenagers has nearly
- 7 tripled since the 1940s; the rate in Texas is nearly double the
- 8 national average, and suicide is the second leading cause of death
- 9 among Texans aged 15 to 34; and
- 10 WHEREAS, Further compounding the problem, many schools
- 11 across the state have student-to-counselor ratios that greatly
- 12 exceed the recommendations of the Texas Model for Comprehensive
- 13 School Counseling Programs adopted by the State Board of Education;
- 14 and
- WHEREAS, It is estimated that more than 20 veterans commit
- 16 suicide every day in the United States, a rate 1.5 times higher than
- 17 that of the general population; veterans compose 14 percent of all
- 18 suicide deaths, despite representing only 8 percent of the national
- 19 population; and
- WHEREAS, In Texas, the suicide rate among veterans is more
- 21 than twice that of the state's overall population, and the risk is
- 22 more pronounced for those who served in recent conflicts, such as
- 23 the wars in Iraq and Afghanistan; suicide among veterans aged 18-34
- 24 rose by 10 percent between 2006 and 2016, translating to 45 deaths

- 1 for every 100,000 veterans, the largest increase for any age group;
- 2 and
- 3 WHEREAS, Many factors impact veterans' mental health and
- 4 well-being, including family and employment issues and the
- 5 challenge of reintegrating into civilian society; those men and
- 6 women who have served our country are in dire need of services to
- 7 assist with life transitions and the stresses that can arise from
- 8 them; and
- 9 WHEREAS, Mental health care for veterans is an area of
- 10 particular need in our state, and a 2015 report by The University of
- 11 Texas outlined the benefits of providing coordinated mental health
- 12 services for Texas veterans; and
- WHEREAS, In the Coastal Bend of Texas, students, teachers,
- 14 counselors, administrators, veterans, and community advocates have
- 15 joined together to study the causes and effects of suicide among
- 16 veterans and adolescents in the state; the coalition conducted two
- 17 public forums in the spring of 2019 to focus attention on these
- 18 issues, and the discussions have resulted in recommendations
- 19 brought forth for consideration during the 86th Texas Legislature;
- 20 now, therefore, be it
- 21 RESOLVED, That the House of Representatives of the 86th Texas
- 22 Legislature hereby recognize the participants in the Coastal Bend
- 23 forums for their efforts to address the tragic problem of suicide in
- 24 the state and extend sincere appreciation to these caring
- 25 individuals.
