Paschal High School in 1962 before continuing his studies at Texas Christian University; in 1968, he enlisted in the United States Army, and he was deployed to Germany to serve during the Vietnam War; and

11 WHEREAS, After returning home to Fort Worth and Eagle 12 Mountain Lake, Mr. Lauderdale met and married Carol Godbey, with whom he shared the joy of raising two children, Christopher and 13 14 Leigh Anne; he was actively involved in his children's lives and supported them by coaching their soccer and basketball teams and 15 riding horses competitively with his daughter; no matter the 16 activity, he always made it his goal to instill in them morals, 17 values, and life lessons, and he served as a role model to them 18 through his generosity and compassion toward others; and 19

20 WHEREAS, An entrepreneur, Mr. Lauderdale decided to strike 21 out on his own after working for a time in the poultry business and 22 became the president, owner, and operator of Fort Worth Poultry & 23 Egg Company at the Fort Worth Stockyards; he enjoyed spending time 24 on the water, whether waterskiing competitively or sailing, and

10 WHEREAS, Gilmore Lauderdale made a positive impact in many 11 lives through his personal and professional achievements, and he 12 will forever be remembered with admiration and affection by those 13 who were fortunate enough to know him; now, therefore, be it
