## RESOLUTION

1 WHEREAS, For more than a century, the Legislative Reference 2 Library has provided invaluable assistance to Texas lawmakers; and 3 WHEREAS, Signaling to the world that the Texas Legislature early on understood the value of a reference library, leaders of 4 this state reserved a special place at the core of the 1888 Capitol 5 to house this vital resource for current and future generations; 6 7 the Legislative Reference Library was established on the second floor in the north wing to assist members of the legislature and 8 9 their staffs, and its resources are also available to the lieutenant governor, the speaker, and their staffs, to the staff of 10 11 the governor's office, to legislative officers, agencies, and 12 committees, to state agencies and commissions, to librarians and legislators from other states, to members of the press, and to Texas 13 14 citizens; and WHEREAS, The tools may change through the decades, but the 15 need for information endures, and the library's electronic data 16 systems currently expedite the delivery of knowledge to the 17 legislative community in both direct and indirect ways; the 18 creation, compilation, and utilization of information in a reliable 19 20 and timely fashion are provided today in a manner unimaginable by

the legislature in 1888, yet the importance of the LRL's continued

proximity to the seat of Texas government was reaffirmed during the

restoration of the Capitol in the 1990s, thus underscoring the

intrinsic value of this treasured institution; and

WHEREAS, The effectiveness of the library would not be 1 possible without the talented people who staff 2 it; these 3 individuals provide in-depth analyses of legislation from all 50 states, respond to historical legislative queries, and create ad 4 5 hoc legislative statistical reports for staff in the speaker's and lieutenant governor's offices; during legislative sessions, the 6 library plays an integral part in the legislative process; staff 7 8 develop electronic records in the Texas Legislative Tracking System for each bill or resolution filed and furnish real-time information 9 10 to the legislative community, to executive agencies, and to citizens of this state through such proprietary applications as 11 12 TLIS and TLO; and WHEREAS, Stationed on the floor of the house and senate 13 14 chambers, library staff enter legislative actions as they occur, 15 and they work closely with the senate and house parliamentarians, senate and house journal clerks, chief clerk of the house, 16 17 secretary of the senate, and their staffs to ensure that records are accurate and complete; library staff members are also responsible 18 19 assigning and entering subject terms and relationships, and they review enrolled legislation for effective 20 21 dates of each measure; in addition, the library operates a toll-free bill status hotline; and 22 23 WHEREAS, The LRL maintains the most comprehensive physical 24 repository of information relating to the Texas Legislature, including original legislative bill files from the 63rd Session to 25 26 the present, historical and current publications of legislative

committees, state agencies, and institutions of higher education,

and legislative legal resources, journals, 1 law reviews, and periodicals; a circulating collection of materials is also made 2 3 available to the legislative community; and 4 WHEREAS, Each business day, the library compiles select 5 articles from newspapers statewide for the legislative community, and it generates weekly listings of important journal articles and 6 quarterly listings of newsworthy additions to the library's 7 legislative information electronically through a number

8 collection; the LRL strives to provide accurate and up-to-date 9 10 databases; the Texas Appointment System contains information on members of state councils, boards, and committees appointed by the 11 12 governor, lieutenant governor, and speaker; the Legislative Archive System holds the only electronic version of original 13 14 legislative bill files and documentation, while the Index to 15 Sections Affected is the sole source of information detailing the proposed statutory effect of bills; moreover, the library maintains 16 17 Texas Legislators: Past & Present, highlighting legislative membership information from 1846 to today, as well as a legislative 18 19 reports database covering that same period, and it archives gubernatorial executive orders, messages, and proclamations; and 20 21 WHEREAS, Guided skillfully by director/librarian Mary Camp, the LRL staff includes assistant director/librarian Catherine 22 23 Wusterhausen, administrative/legislative staff Donald Brower, 24 Elizabeth Buchanan, Michelle Martinez, Kali Palmer, Christopher Taylor, Julia Walden, and Erin Willard, clipping service staffers 25 26 Vincent Cowan, David Wood, Karen Wright, and Jay Young, and 27 librarians Ali Dzienkowski, Cassandra Gallegos, Sally Harlow,
