(a) In this section: 8

- 9 (1) "Broadband service" means Internet service with

The electric cooperative or electric 6 7 cooperative affiliate shall send the notice by first class mail to 8 the last known address of each person in whose name the property is listed on the most recent tax roll of each county authorized to levy 9 property taxes against the property. - 2 (g) This section may not be construed to:
- 3 (1) conflict with or limit the provisions of Chapter

- 5 (2) limit or prohibit an electric cooperative's use of

- 7 to operate and maintain the electric cooperative's electric
