## A BILL TO BE ENTITLED

1 AN ACT relating to oversight of and requirements applicable to state 2 3 agency contracting and procurement. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 441.1855, Government Code, is amended to 5 6 read as follows: Sec. 441.1855. RETENTION OF CONTRACT AND RELATED DOCUMENTS 7 8 BY STATE AGENCIES. (a) Notwithstanding Section 441.185 or 441.187, a state agency: 9 shall retain in its records each contract entered 10 (1)into by the state agency and all contract solicitation documents 11 12 related to the contract; and (2) may destroy the contract and documents only after 13 the seventh anniversary of the date: 14 15 (A) the contract is completed or expires; or all issues that arise from any litigation, 16 (B) 17 claim, negotiation, audit, open records request, administrative review, or other action involving the contract or documents are 18 19 resolved. (b) A contract solicitation document that is an electronic 20 document must be retained under Subsection (a) in the document's 21 22 electronic form. A state agency may print and retain the document in paper form only if the agency provides for the preservation, 23 examination, and use of the electronic form of the document in 24

2	formulas that are part of the electronic format of the document.
3	(c) In this section:
4	(1) "Contract solicitation document" includes any
5	document, whether in paper form or electronic form, that is used by
6	a state agency to evaluate responses to a competitive solicitation
7	for a contract issued by the agency.
8	(2) "Electronic document" means:
9	(A) information that is created, generated,
10	sent, communicated, received, or stored by electronic means; or
11	(B) the output of a word processing, spreadsheet,
12	presentation, or business productivity application.
13	SECTION 2. Section 2054.003(10), Government Code, is
14	amended to read as follows:
15	(10) "Major information resources project" means:
16	(A) any information resources technology project
17	identified in a state agency's biennial operating plan whose
18	development costs exceed $\frac{55}{5}$ [ <del>\$1</del> ] million and that:
19	(i) requires one year or longer to reach

21	(ii) involves more than one state agency;
22	or
23	(iii) substantially alters work methods of
24	state agency personnel or the delivery of services to clients; and
25	(B) any information resources technology project
26	designated by the legislature in the General Appropriations Act as
27	a major information resources project.

(9) provide a summary of agency and statewide resultsin providing access to electronic and information resources to

1 individuals with disabilities as required by Subchapter M;

2 (10) assess the progress made toward accomplishing the 3 goals of the plan for a state telecommunications network and 4 developing a system of telecommunications services as provided by 5 Subchapter H; and

6 (11) identify proposed major information resources 7 projects for the next state fiscal biennium, including project 8 costs through stages of the project and across state fiscal years 9 from project initiation to implementation[+

10 [(12) examine major information resources projects 11 completed in the previous state fiscal biennium to determine the 12 performance of the implementing state agency, cost and value 13 effectiveness, timeliness, and other performance criteria 14 necessary to assess the quality and value of the investment; and

15 [(13) examine major information resources projects 16 after the second anniversary of the project's completion to 17 determine progress toward meeting performance goals and operating 18 budget savings].

Subchapter F, Chapter 2054, Government Code, is 13 amended by adding Section 2054.137 to read as follows: 14 15 Sec. 2054.137. APPROVAL REQUIRED FOR ASSIGNMENT OF CERTAIN 16 CONTRACTS. (a) In this section, "sensitive personal information" has the meaning assigned by Section 521.002, Business & Commerce 17 Code. 18 (b) This section applies only to a contract awarded by a 19 state agency: 20 21 (1) for a major information resources project; or 22 (2) involving sensitive personal information. (c) A vendor may not assign the vendor's rights under a 23 contract to which this section applies to a third party unless the 24 25 assignment is approved by the quality assurance team. 26 (d) A state agency that receives notice that a vendor 27 proposes to make an assignment subject to approval under Subsection

computer software system for compliance requirements related to the 1 2 procurement of goods or services may electronically submit to the 3 comptroller using that computer software system a written justification, verification, notification, or acknowledgement 4 required under this chapter or Subchapter B, Chapter 2155. 5 6 SECTION 28. Subchapter B, Chapter 2262, Government Code, is 7 amended by adding Section 2262.053 to read as follows: Sec. 2262.053. CONTRACT FILE CHECKLIST; CERTIFICATION OF 8 AGENCY COMPLIANCE. (a) <u>Each state agency shall include in the</u> 9 contract file for each of its contracts a checklist to ensure the 10 agency's compliance with state laws and rules relating to the 11 acquisition of goods and services by the agency. 12 13 (b) The comptroller shall develop and periodically update a model contract file checklist and make the checklist available for 14 use by state agencies. The comptroller shall periodically update 15 the checklist. 16 17 (c) The comptroller may adopt rules necessary to develop or update the model contract file checklist. 18 (d) The model contract file checklist must address each 19 20 stage of the procurement process and must include, at a minimum, a 21 description of: 22 (1) the documents that are required to be maintained 23 during each stage of the procurement process in accordance with 24 applicable state laws and comptroller rules; and 25 (2) the procedures and documents that are required to be completed during the following stages of the procurement 26 27 process:

4	(e) A state agency may develop its own contract file		
5	checklist based on the procurement and contracting needs of that

10	(f) Before a state agency awards a contract to a vendor for

As soon as practicable after the effective date 12 13 of this Act, the comptroller of public accounts, the Department of Information Resources, and each affected state agency as necessary, 14 15 shall adopt the rules, processes, and procedures and take the 16 actions necessary to implement the changes in law made by this Act. SECTION 31. (a) Except as provided by Subsections (b) and 17 (c), this Act applies only in relation to a contract: 18 (1) for which a state agency first advertises or 19 20 otherwise solicits bids, proposals, offers, or qualifications on or after the effective date of this Act; 21

(2) that is extended or modified on or after theeffective date of this Act; or

(3) for which a change order is submitted on or afterthe effective date of this Act.

(b) Section 2054.137, Government Code, as added by this Act,
applies only to a contract entered into or renewed on or after the

1 effective date of this Act.

2 (c) The changes in law made by this Act that apply to a major consulting services contract apply only to a major consulting 3 services contract entered into or amended, modified, renewed, or 4 extended on or after the effective date of this Act. A major 5 consulting services contract entered into or amended, modified, 6 7 renewed, or extended before the effective date of this Act is governed by the law in effect on the date the contract was entered 8 9 into or amended, modified, renewed, or extended, and the former law 10 is continued in effect for that purpose.

11 SECTION 32. Notwithstanding Section 2261.258, Government 12 Code, as added by this Act, the first report required under that 13 section is due on or before September 1, 2020.

14 SECTION 33. This Act takes effect September 1, 2019.
