A BILL TO BE ENTITLED

1	AN ACT
2	relating to a ribbon for certain members of the military forces who
3	served in support of operations to secure the Texas border.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 437.355(a), Government Code, is amended
6	to read as follows:
7	(a) The governor or adjutant general, if delegated the
8	authority, may adopt policies and regulations relating to awarding:
9	(1) the Texas Purple Heart Medal, which shall be
10	awarded to a service member who:
11	(A) after September 11, 2001:
12	(i) was inducted into federal service from
13	the Texas National Guard; and
14	(ii) meets the criteria for an award of the
15	federal Purple Heart Medal; or
16	(B) was wounded or killed at Fort Hood on
17	November 5, 2009;
18	(2) the Texas Superior Service Medal, which shall be
19	awarded to:
20	(A) a service member of the Texas military forces
21	who has:
22	(i) completed 30 or more years of honorable
23	state service or a combination of state and federal service; and

(ii) continually demonstrated superior

- 1 performance and service while assigned to key leadership positions
- 2 demanding responsibility; or
- 3 (B) a civilian who has contributed significant
- 4 service to the Texas military forces;
- 5 (3) the Lone Star Distinguished Service Medal, which
- 6 shall be awarded to a member of the military forces of this state,
- 7 another state, or the United States for exceptionally outstanding
- 8 achievement or service to this state in performance of a duty of
- 9 great responsibility while serving with the Texas military forces
- 10 for whom the department receives a letter of recommendation for
- 11 award of the Lone Star Distinguished Service Medal that:
- 12 (A) gives an account of the exceptional
- 13 achievement or service; and
- 14 (B) includes facts and photographs, and extracts
- 15 from official documents to support and amplify the facts;
- 16 (4) the Texas Outstanding Service Medal, which shall
- 17 be awarded to a service member of the military forces of this state,
- 18 another state, or the United States who has performed service in a
- 19 superior and clearly outstanding manner;
- 20 (5) the Texas Humanitarian Service Medal, which shall
- 21 be awarded to a service member who:
- (A) does not meet the criteria for an award of the
- 23 federal Humanitarian Service Medal;
- 24 (B) is a member of the Texas military forces; and
- (C) while serving on state active duty or active
- 26 duty under state authority in accordance with Title 32, United
- 27 States Code, participates satisfactorily in defense support to a

- 1 mission under civilian authority to protect life or property during
- 2 or soon after a natural disaster or civil unrest in the state;
- 3 (6) the Texas Homeland Defense Service Medal, which
- 4 shall be awarded to a service member of the Texas military forces
- 5 who served:
- 6 (A) on or after September 11, 2001;
- 7 (B) on state active duty or active duty under
- 8 state authority in accordance with Title 32, United States Code;
- 9 and
- 10 (C) satisfactorily in defense support to a
- 11 mission in the state under civilian authority;
- 12 (7) the Federal Service Medal, which shall be awarded
- 13 to a service member who was inducted into federal service from the
- 14 Texas military forces between June 15, 1940, and January 1, 1946, or
- 15 after June 1, 1950, if the service was for more than 90 days;
- 16 (8) the Texas Combat Service Ribbon, which shall be
- 17 awarded to a service member of the Texas National Guard who served,
- 18 after September 11, 2001, in a hostile fire zone as designated by
- 19 the United States secretary of defense;
- 20 (9) the Texas Faithful Service Medal, which shall be
- 21 awarded to a member of the Texas military forces who has completed
- 22 five years of honorable service during which the service member has
- 23 shown fidelity to duty, efficient service, and great loyalty to
- 24 this state;
- 25 (10) the Texas Medal of Merit, which shall be awarded
- 26 to a member of the military forces of this state, another state, or
- 27 the United States who performs outstanding service or attains

- 1 extraordinary achievement in behalf of the state or United States;
- 2 (11) the Texas State Guard Service Medal, which shall
- 3 be awarded to a service member who completes three consecutive
- 4 years of honorable service in the Texas State Guard during which the
- 5 service member has shown fidelity to duty, efficient service, and
- 6 great loyalty to this state;
- 7 (12) the Texas Desert Shield/Desert Storm Campaign
- 8 Medal, which shall be awarded to a service member who was inducted
- 9 into federal service from the Texas National Guard after August 1,
- 10 1990, in support of Operation Desert Shield or Operation Desert
- 11 Storm, without regard to the place that the service member was
- 12 deployed while serving on active federal military duty;
- 13 (13) the Texas Iraqi Campaign Medal, which shall be
- 14 awarded to a service member who was inducted into federal service
- 15 from the Texas National Guard, without regard to the place that the
- 16 service member was deployed while serving on active federal
- 17 military duty, after:
- 18 (A) March 19, 2003, in support of Operation Iraqi
- 19 Freedom; or
- 20 (B) August 31, 2010, in support of Operation New
- 21 Dawn;
- 22 (14) the Texas Afghanistan Campaign Medal, which shall
- 23 be awarded to a service member who was inducted into federal service
- 24 from the Texas National Guard after October 6, 2001, in support of
- 25 Operation Enduring Freedom, without regard to the place that the
- 26 service member was deployed while serving on active federal
- 27 military duty; [and]

- 1 (15) the Cold War Medal, which, subject to Subsection
- 2 (c), shall be awarded to a member of the military forces of this
- 3 state or the United States who:
- 4 (A) served between September 2, 1945, and
- 5 December 26, 1991; and
- 6 (B) was a resident of this state at the time the
- 7 service member entered military service; and
- 8 (16) the Texas Border Security and Support Service
- 9 Ribbon, which shall be awarded to a member of the state military
- 10 forces who served:
- 11 <u>(A) on or after July 28, 2014;</u>
- 12 (B) on state active duty for at least 30
- 13 consecutive days; and
- (C) satisfactorily in support of operations to
- 15 secure the Texas border.
- SECTION 2. This Act takes effect September 1, 2019.
