2	relating to the requirements for the issuance of identification
3	documentation for foster care youth.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 191, Health and Safety
6	Code, is amended by adding Section 191.0049 to read as follows:
7	Sec. 191.0049. BIRTH RECORD ISSUED TO FOSTER CHILD; PILOT
8	PROGRAM. (a) In this section, "foster child" means a person who is
9	16 years of age or older and in the managing conservatorship of the
10	Department of Family and Protective Services.
11	(b) On request of a foster child, the state registrar, a
12	local registrar, or a county clerk shall issue, without a fee, a
13	certified copy of the foster child's birth record.
14	(c) The department shall participate in a foster child
15	identification verification pilot program for the purpose of
16	issuing birth records to foster children.
17	(d) Under the pilot program, the department may:
18	(1) enter into a memorandum of understanding with the
19	Department of Family and Protective Services to establish an
20	identification verification process for foster children; and
21	(2) issue a birth certificate to a foster child whose
22	identity has been confirmed through the verification process.
23	(e) At the conclusion of the pilot program, the
24	participating agencies may agree to continue the pilot program on a

1	permanent basis.
2	(f) Not later than January 1, 2019, the department and the
3	Department of Family and Protective Services shall jointly issue a
4	report to the legislature addressing the status and effectiveness
5	of the pilot program. This subsection expires September 1, 2019.
6	SECTION 2. Subchapter E, Chapter 521, Transportation Code,
7	is amended by adding Section 521.1015 to read as follows:
8	Sec. 521.1015. PERSONAL IDENTIFICATION CERTIFICATE ISSUED
9	TO FOSTER CHILD. (a) In this section, "foster child" means a
10	person who is 16 years of age or older and in the managing
11	conservatorship of the Department of Family and Protective
12	Services.
13	(b) Notwithstanding Section 521.101, Section 521.1426, or
14	any other provision of this chapter, a foster child may, in applying
15	for a personal identification certificate:
16	(1) provide a copy of the foster child's birth
17	certificate or a copy of the foster child's social security card as
18	proof of the foster child's identity and United States citizenship,
19	as applicable; and
20	(2) use the address of the regional office where the
21	Department of Family and Protective Services caseworker for the
22	foster child is based, if the foster child:
23	(A) does not have a residence or domicile; or
24	(B) cannot show proof of the foster child's
25	residence or domicile.
26	(c) A foster child may apply for and the department may
27	issue a personal identification certificate without the signature

or presence of or permission from a parent or guardian of the foster
 child.

3 (d) A foster child is exempt from the payment of any fee for
4 the issuance of a personal identification certificate under this
5 chapter.

6 SECTION 3. The changes in law made by this Act apply only to 7 a request for a birth record or an application for a personal identification certificate submitted on or after the effective date 8 9 of this Act. A request for a birth record or an application for a personal identification certificate submitted before the effective 10 date of this Act is governed by the law as it existed immediately 11 before the effective date of this Act, and that law is continued in 12 effect for that purpose. 13

SECTION 4. This Act takes effect September 1, 2017.
