1-19 A BILL TO BE ENTITLED 1-20 AN ACT

> relating to the use of information from the lists of noncitizens and nonresidents excused or disqualified from jury service.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 18.068(a), Election Code, is amended to read as follows:

- (a) The secretary of state shall quarterly compare the information received under Section 16.001 of this code and <u>Sections</u> [Section] 62.113 and 62.114, Government Code, to the statewide computerized voter registration list. If the secretary determines that a voter on the registration list is deceased or has been excused or disqualified from jury service because the voter is not a citizen or a resident of the county in which the voter is registered to vote, the secretary shall send notice of the determination to:
- (1) the voter registrar of the counties considered appropriate by the secretary; and
- (2) the attorney general, who shall quarterly review the information to investigate whether a person has committed an offense under Section 13.007 or other law.
- SECTION 2. Section 62.113(b), Government Code, is amended to read as follows:
- On the third business day of each month, the clerk shall (b) send a copy of the list of persons excused or disqualified because of citizenship in the previous month to:
 - (1)the voter registrar of the county;
 - (2)
- the secretary of state; and the county or district attorney, as applicable, or the attorney general for an investigation of whether the person committed an offense under Section 13.007, Election Code, or other law.
- SECTION 3. Sections 62.114(b) and (c), Government Code, are amended to read as follows:
- (b) On the third business day of each month, the clerk shall send [to the voter registrar of the county] a copy of the list of persons excused or disqualified in the previous month because the persons do not reside in the county to:
 - (1)the voter registrar of the county;
 - the secretary of state; and (2)
- (3) the county or district attorney, as applicable, or 1-58 the attorney general for an investigation of whether the person 1-59 committed an offense under Section 13.007, Election Code, or other 1-60
