teachers, to effectively teach: 1 2 (A) students with disabilities; and (B) students of limited English proficiency, as 3 4 defined by Section 29.052; 5 the activities offered by the program that are (5) designed to prepare teachers to: 6 7 (A) integrate technology effectively into curricula and instruction, including activities consistent with 8 9 the principles of universal design for learning; and technology effectively 10 (B) use to collect, 11 manage, and analyze data to improve teaching and learning for the purpose of increasing student academic achievement; 12 13 (6) for each semester, the average ratio of field supervisors to candidates completing student teaching, clinical 14 teaching, or an internship in an educator preparation program; 15 16 (7) [the percentage of teachers employed under 17 standard teaching certificate within one year of completing the 18 program; [(8)] the perseverance of beginning teachers in the 19 20 profession, as determined on the basis of the number of beginning teachers who maintain status as active contributing members in the 21 Teacher Retirement System of Texas for at least three years after 22 certification in comparison to similar programs; 23 24 (8) [(9)] the results of exit surveys given to program participants on completion of the program that involve evaluation 25 of the program's effectiveness in preparing participants to succeed 26

in the classroom;

1 (9) [(10)] the results of surveys given to school 2 principals that involve evaluation of the program's effectiveness 3 in preparing participants to succeed in the classroom, based on 4 experience with employed program participants; and

5 <u>(10)</u> [(11)] the results of teacher satisfaction 6 surveys developed under Section 21.045 and given to program 7 participants at the end of the first year of teaching.
