

AN ACT

relating to certain required reports received or prepared by state agencies and other governmental entities.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE 1. REPORTS REQUIRED OF STATE AGENCIES

SECTION 1.01. Section 21.0452(b), Education Code, is amended to read as follows:

(b) The board shall make available at least the following information regarding each educator preparation program:

(1) the information specified in Sections 21.045(a) and (b);

(2) in addition to any other appropriate information indicating the quality of persons admitted to the program, the average academic qualifications possessed by persons admitted to the program, including:

(A) average overall grade point average and average grade point average in specific subject areas; and

(B) average scores on the Scholastic Assessment Test (SAT), the American College Test (ACT), or the Graduate Record Examination (GRE), as applicable;

(3) the degree to which persons who complete the program are successful in obtaining teaching positions;

(4) the extent to which the program prepares teachers, including general education teachers and special education

1 teachers, to effectively teach:

2 (A) students with disabilities; and

3 (B) students of limited English proficiency, as
4 defined by Section 29.052;

5 (5) the activities offered by the program that are
6 designed to prepare teachers to:

7 (A) integrate technology effectively into
8 curricula and instruction, including activities consistent with
9 the principles of universal design for learning; and

10 (B) use technology effectively to collect,
11 manage, and analyze data to improve teaching and learning for the
12 purpose of increasing student academic achievement;

13 (6) for each semester, the average ratio of field
14 supervisors to candidates completing student teaching, clinical
15 teaching, or an internship in an educator preparation program;

16 ~~(7) [the percentage of teachers employed under a
17 standard teaching certificate within one year of completing the
18 program,~~

19 ~~[(8)]~~ the perseverance of beginning teachers in the
20 profession, as determined on the basis of the number of beginning
21 teachers who maintain status as active contributing members in the
22 Teacher Retirement System of Texas for at least three years after
23 certification in comparison to similar programs;

24 (8) ~~[(9)]~~ the results of exit surveys given to program
25 participants on completion of the program that involve evaluation
26 of the program's effectiveness in preparing participants to succeed
27 in the classroom;

1 (9) [~~(10)~~] the results of surveys given to school
2 principals that involve evaluation of the program's effectiveness
3 in preparing participants to succeed in the classroom, based on
4 experience with employed program participants; and

5 (10) [~~(11)~~] the results of teacher satisfaction
6 surveys developed under Section 21.045 and given to program
7 participants at the end of the first year of teaching.

8 SECTION 1.02. Section 51.402(b), Education Code, is amended
9 to read as follows:

10 (b) The governing board of each institution of higher
11 education in the state shall adopt rules and regulations concerning
12 faculty academic workloads. In adopting rules under this
13 subsection, each institution shall recognize that classroom
14 teaching, basic and applied research, and professional development
15 are important elements of faculty academic workloads by giving
16 appropriate weight to each activity when determining the standards
17 for faculty academic workload. An institution may give the same or
18 different weight to each activity and to other activities
19 recognized by the institution as important elements of faculty
20 academic workloads. The established rules and regulations of each
21 institution shall be [~~reported to the coordinating board and~~]
22 included in the operating budgets of each institution.

23 SECTION 1.03. Section 51.680(c), Education Code, is amended
24 to read as follows:

25 (c) It is a policy of the state that each institution of
26 higher education shall at all times [~~after August 31, 1988,~~] have a
27 current copy of its intellectual property policies that meet the

1 minimum standards set out in Subsection (a) [~~on file with the Texas~~
2 ~~Higher Education Coordinating Board or~~] posted on the institution's
3 website on the Internet in a manner available to the public. The
4 commissioner of higher education shall establish procedures for the
5 monitoring of this policy of the state.

6 SECTION 1.04. Section 51.751(b), Education Code, is amended
7 to read as follows:

8 (b) The center shall examine the efficiency of the public
9 school system and the effectiveness of instructional methods and
10 curricular programs and promote the use of successful methods and
11 programs. The center shall monitor and evaluate the implementation
12 of the accountability system under Chapters 39 and 39A [~~and provide~~
13 ~~annual progress reports to the governor, Legislative Budget Board,~~
14 ~~and commissioner of education~~].

15 SECTION 1.05. Section 52.335, Education Code, is amended by
16 adding Subsection (b-1) to read as follows:

17 (b-1) A participating higher educational institution is not
18 required to provide in any disclosure or report required under this
19 section information regarding loans issued by a private entity.

20 SECTION 1.06. Section 531.028(b), Government Code, is
21 amended to read as follows:

22 (b) The executive commissioner shall establish a federal
23 money management system to coordinate and monitor the use of
24 federal money that is received by health and human services
25 agencies to ensure that the money is spent in the most efficient
26 manner and shall:

27 (1) establish priorities for use of federal money by

1 all health and human services agencies, in coordination with the
2 coordinated strategic plan established under Section 531.022 [~~and~~
3 ~~the budget prepared under Section 531.026~~];

4 (2) coordinate and monitor the use of federal money
5 for health and human services to ensure that the money is spent in
6 the most cost-effective manner throughout the health and human
7 services system;

8 (3) review and approve all federal funding plans for
9 health and human services in this state;

10 (4) estimate available federal money, including
11 earned federal money, and monitor unspent money;

12 (5) ensure that the state meets federal requirements
13 relating to receipt of federal money for health and human services,
14 including requirements relating to state matching money and
15 maintenance of effort;

16 (6) transfer appropriated amounts as described by
17 Section 531.0271; and

18 (7) ensure that each governmental entity identified
19 under Section 531.022(e) has access to complete and timely
20 information about all sources of federal money for health and human
21 services programs and that technical assistance is available to
22 governmental entities seeking grants of federal money to provide
23 health and human services.

24 SECTION 1.07. Sections 531.421(3) and (4), Government Code,
25 are amended to read as follows:

26 (3) [~~"Consortium" means the Texas System of Care~~
27 ~~Consortium established under Subchapter C-1.~~

1 ~~(4)~~ "Systems of care services" means a comprehensive
2 state system of mental health services and other necessary and
3 related services that is organized as a coordinated network to meet
4 the multiple and changing needs of children with severe emotional
5 disturbances and their families.

6 SECTION 1.08. Section 531.422(c), Government Code, is
7 amended to read as follows:

8 (c) Each community resource coordination group shall submit
9 the report described by Subsection (b) to the commission
10 ~~[consortium]~~. The commission ~~[consortium]~~ shall provide ~~[a~~
11 ~~deadline]~~ to each group a deadline for submitting the reports that
12 is~~[. The time frame for completing the reports must be]~~ coordinated
13 with any regional reviews by the commission of the delivery of
14 related services.

15 SECTION 1.09. Section 531.423, Government Code, is amended
16 to read as follows:

17 Sec. 531.423. SUMMARY REPORT BY COMMISSION ~~[CONSORTIUM]~~.

18 (a) The commission ~~[consortium]~~ shall create a summary report
19 based on the evaluations in the reports submitted to the commission
20 ~~[consortium]~~ by community resource coordination groups under
21 Section 531.422. The commission's ~~[consortium's]~~ report must
22 include recommendations for policy and statutory changes at each
23 agency that is involved in the provision of systems of care services
24 and the outcome expected from implementing each recommendation.

25 (b) The commission ~~[consortium]~~ shall coordinate, where
26 appropriate, the recommendations in the report created under this
27 section with recommendations in the assessment developed under

1 Chapter 23 (S.B. ~~No.~~ 491), Acts of the 78th Legislature, Regular
2 Session, 2003, and with the continuum of care developed under
3 Section 533.040(d), Health and Safety Code [~~S.B. No. 490, Acts of~~
4 ~~the 78th Legislature, Regular Session, 2003~~].

5 (c) The commission [~~consortium~~] may include in the report
6 created under this section recommendations for the statewide
7 expansion of sites participating in the Texas System of Care and the
8 integration of services provided at those sites with services
9 provided by community resource coordination groups.

10 (d) The commission [~~consortium~~] shall provide a copy of the
11 report created under this section to each agency for which the
12 report makes a recommendation and to other agencies as appropriate.

13 SECTION 1.10. Section 2003.108, Government Code, is amended
14 to read as follows:

15 Sec. 2003.108. PENDING CASE STATUS REVIEW [~~REPORTS~~].

16 [~~(a) The office shall provide the comptroller a monthly status~~
17 ~~report that lists pending cases and provides information on any~~
18 ~~case that exceeds the comptroller's time lines for issuing a~~
19 ~~proposal for decision or an agreed order.~~

20 [~~(b)~~] At least quarterly, the office shall review with the
21 comptroller and appropriate staff of the office the status of
22 pending cases under this subchapter.

23 [~~(c) The office shall provide a quarterly report to the~~
24 ~~comptroller on services performed by the office for the comptroller~~
25 ~~under this subchapter.]~~

26 SECTION 1.11. Section 2054.075(b), Government Code, is
27 amended to read as follows:

1 (b) Each state agency [~~shall provide that its~~] information
2 resources manager is part of the agency's executive management and
3 reports directly [~~to a person with a title functionally equivalent~~]
4 to the executive head [~~director~~] or deputy executive head of the
5 agency [~~director~~]. Each state agency shall report to the
6 department the extent and results of its compliance with this
7 subsection and include with the report an organizational chart
8 showing the structure of the personnel in the agency's executive
9 management. The [~~, and the~~] department shall report the extent and
10 results of state agencies' compliance with this subsection to the
11 legislature.

12 SECTION 1.12. Section 2054.100(a), Government Code, is
13 amended to read as follows:

14 (a) Each state agency shall submit an operating plan to the
15 Legislative Budget Board, [~~the department,~~] the quality assurance
16 team, and the governor each state fiscal biennium in accordance
17 with the directions of the Legislative Budget Board.

18 SECTION 1.13. Section 2054.103, Government Code, is amended
19 to read as follows:

20 Sec. 2054.103. SUBMISSION OF OPERATING PLANS. Each state
21 agency shall send a copy of its biennial operating plan and of any
22 amendments to the plan, as approved by the Legislative Budget
23 Board, to the governor [~~, the department,~~] and the state auditor not
24 later than the 30th day after the date the Legislative Budget Board
25 approves the plan or amendment, as applicable.

26 SECTION 1.14. Sections 2054.133(c) and (f), Government
27 Code, are amended to read as follows:

2 year, each state agency shall submit a copy of the agency's
3 information security plan to the department. Subject to available
4 resources, the department may select a portion of the submitted

18 copies of the report information that could expose specific
19 vulnerabilities in the security of this state's information
20 resources.

21 SECTION 1.15. Section 2054.304(b), Government Code, is
22 amended to read as follows:

23 (b) Except as provided by Subsection (c), the state agency
24 must file the project plan with the quality assurance team [~~and the~~
25 ~~department~~] before the agency:

26 (1) spends more than 10 percent of allocated funds for
27 the project or major contract; or

1 (2) first issues a vendor solicitation for the project
2 or contract.

3 SECTION 1.16. Section 2054.515(b), Government Code, is
4 amended to read as follows:

5 (b) Not later than December 1 of the year in which a state
6 agency conducts the assessment under Subsection (a), the agency
7 shall report the results of the assessment to:

8 (1) the department; and

9 (2) on request, the governor, the lieutenant governor,
10 and the speaker of the house of representatives.

11 SECTION 1.17. Section 2056.002(d), Government Code, is
12 amended to read as follows:

13 (d) A state agency shall send two copies of each plan to both
14 the Legislative Reference Library and the state publications
15 clearinghouse of the Texas State Library and one copy each to:

16 (1) the governor;

17 (2) the lieutenant governor;

18 (3) the speaker of the house of representatives;

19 (4) the Legislative Budget Board; and

20 (5) ~~[the Sunset Advisory Commission,~~

8 programs, including programs under this chapter. The laboratory
9 shall calculate, based on the evaluation and the forms submitted to
10 the office, the amount of energy savings and estimated reduction in
11 pollution achieved as a result of the implementation of programs.
12 The laboratory shall share the information with the commission, the
13 United States Environmental Protection Agency, and the Electric
14 Reliability Council of Texas to help with long-term forecasting and
