BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Section 51.803, Education Code, is amended by 7 adding Subsection (d-1) and amending Subsection (h) to read as 8 9 follows: (d-1) In addition to admissions required under Subsection 10 (a), each general academic teaching institution shall admit an 11 applicant for admission to the institution as an undergraduate 12 student if the applicant graduated as the valedictorian of the 13 14 student's high school graduating class in one of the two school years preceding the academic year for which the student is applying 15 16 for admission and satisfies the requirements of Subsections (a)(1) through (3). Subsection (b) applies to an applicant for admission 17 under this subsection. 18 An institution that admits under this section an 19 (h) applicant qualified for automatic admission under Subsection (a) or 20 (d-1) may admit the applicant for either the fall semester of the 21 academic year for which the applicant applies or for the summer 22 23 session preceding that fall semester, as determined by the 24 institution.

1 SECTION 2. Section 56.484, Education Code, is amended to

3 Sec. 56.484. INITIAL ELIGIBILITY FOR SCHOLARSHIP. To be 4 eligible for a scholarship under this subchapter, a student must:

5 (1) have graduated from a public or accredited private 6 high school in this state while ranked in the top 10 percent <u>or as</u> 7 <u>the valedictorian</u> of the student's graduating class, subject to 8 Section 56.487(b);

9 (2) have completed the recommended or advanced high 10 school curriculum established under Section 28.025 or its 11 equivalent;

12 (3) have applied for admission as a first-time 13 freshman student for the 2010-2011 academic year or a subsequent 14 academic year to an institution of higher education that has 15 elected to offer admissions for that academic year to applicants as 16 provided by Section 51.803(a-1);

17 (4) enroll as a first-time freshman student in an 18 institution of higher education not later than the 16th month after 19 the date of the student's high school graduation;

(5) have been awarded a TEXAS grant under Subchapter M
for the same semester or other academic term for which the
scholarship will be awarded;

(6) be a Texas resident under Section 54.052; and

24 (7) comply with any other eligibility requirements25 established by coordinating board rule.

26 SECTION 3. The changes in law made by this Act to Section 27 51.803, Education Code, apply beginning with admissions to a

1 general academic teaching institution for the 2019-2020 academic 2 year. Admissions to a general academic teaching institution for an 3 academic year before that academic year are governed by the law in 4 effect immediately before the effective date of this Act, and the 5 former law is continued in effect for that purpose.

6 SECTION 4. The change in law made by this Act to Section 7 56.484, Education Code, applies beginning with scholarships 8 awarded for the 2019-2020 academic year. Scholarships awarded for 9 an academic year before that academic year are governed by the law 10 in effect immediately before the effective date of this Act, and the 11 former law is continued in effect for that purpose.

12 SECTION 5. This Act takes effect immediately if it receives 13 a vote of two-thirds of all the members elected to each house, as 14 provided by Section 39, Article III, Texas Constitution. If this 15 Act does not receive the vote necessary for immediate effect, this 16 Act takes effect September 1, 2019.
