A BILL TO BE ENTITLED

1	AN ACT
2	relating to the reporting of health care-associated infections and
3	preventable adverse events at health care facilities.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 98.103, Health and Safety Code, is
6	amended by amending Subsection (a) and adding Subsection (a-1) to
7	read as follows:
8	(a) A health care facility[, other than a pediatric and
9	adolescent hospital, shall report to the department each health
10	care-associated infection [the incidence of surgical site
11	infections], including the causative pathogen if the infection is
12	laboratory-confirmed, that occurs [occurring] in the facility and
13	that the federal Centers for Medicare and Medicaid Services
14	requires a facility participating in the Medicare program to report
15	through the federal Centers for Disease Control and Prevention's
16	National Healthcare Safety Network, or its successor [following
17	procedures:
18	[(1) colon surgeries;
19	[(2) hip arthroplasties;
20	[(3) knee arthroplasties;
21	[(4) abdominal hysterectomies;
22	[(5) vaginal hysterectomics;
23	(6) coronary artery bypass grafts; and
24	[(7) vascular procedures].

- 1 (a-1) A health care facility shall report each health
- 2 care-associated infection to the department under this section
- 3 regardless of the facility's participation in Medicare.
- 4 SECTION 2. The following provisions of the Health and
- 5 Safety Code are repealed:
- 6 (1) Section 98.001(10);
- 7 (2) Sections 98.103(b) and (c); and
- 8 (3) Section 98.105.
- 9 SECTION 3. (a) The executive commissioner of the Health
- 10 and Human Services Commission shall adopt rules as necessary to
- 11 implement Section 98.103, Health and Safety Code, as amended by
- 12 this Act, not later than January 1, 2020.
- 13 (b) Section 98.103, Health and Safety Code, as amended by
- 14 this Act, applies only to a report for a health care-associated
- 15 infection occurring on or after January 1, 2020. A report for a
- 16 health care-associated infection occurring before that date is
- 17 governed by the law as it existed on the date the infection
- 18 occurred, and that law is continued in effect for that purpose.
- 19 SECTION 4. The Health and Human Services Commission is
- 20 required to implement a provision of this Act only if the
- 21 legislature appropriates money specifically for that purpose. If
- 22 the legislature does not appropriate money specifically for that
- 23 purpose, the commission may, but is not required to, implement a
- 24 provision of this Act using other appropriations available for that
- 25 purpose.
- SECTION 5. This Act takes effect September 1, 2019.
