BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 28.004(c), Education Code, is amended to read as follows:

- (c) The local school health advisory council's duties include recommending:
- (1)the number of hours of instruction to be provided in health education;
- (2) policies, procedures, strategies, and curriculum appropriate for specific grade levels designed to prevent obesity, cardiovascular disease, Type 2 diabetes, and mental health concerns through coordination of:
  - (A) health education;
  - physical education and physical activity; (B)
  - nutrition services; (C)
  - (D) parental involvement;
- (E) instruction to prevent the of use e-cigarettes, as defined by Section 161.081, Health and Safety Code, and tobacco;
  - (F) school health services;
  - counseling and guidance services; (G)
  - (H) a safe and healthy school environment; and
  - school employee wellness; (I)
- grade and methods appropriate (3) levels of instruction for human sexuality instruction;
- strategies for (4)integrating the curriculum components specified by Subdivision (2) with the following elements in a coordinated school health program for the district:
  - school health services; (A)
  - (B) counseling and guidance services;
  - (C) a safe and healthy school environment; and
  - (D) school employee wellness; [and]
- 1-54 (5) if feasible, joint use agreements or strategies for collaboration between the school district and community 1-55 1-56 organizations or agencies; and 1-57
- 1-58 (6) appropriate grade levels and curriculum instruction regarding opioid addiction and abuse and methods of 1-59 administering an opioid antagonist, as defined by Section 483.101, 1-60 1-61 Health and Safety Code.
