3 SECTION 3. (a) The State Board of Dental Examiners, not 4 later than January 1, 2020, shall:

5 (1) prescribe by rule the requirements for a course to 6 train dental hygienists to administer local anesthetic agents; and

7 (2) develop a procedure for the approval of courses8 described by Subdivision (1) of this subsection.

9 (b) A rule adopted under Subsection (a) of this section must 10 require that a course be offered in a classroom setting at an 11 educational institution accredited by the Commission on Dental 12 Accreditation of the American Dental Association.

13 SECTION 4. This Act takes effect September 1, 2019.
