1-25 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-26 SECTION 1. Section 151.0515(d), Tax Code, is amended to
 1-27 read as follows:

1-28 (d) This section expires August 31, 2021 [~~2019~~].

1-29 SECTION 2. Section 152.0215(c), Tax Code, is amended to
 1-30 read as follows:

1-31 (c) This section expires August 31, 2021 [~~2019~~].

1-32 SECTION 3. Section 501.138(b-3), Transportation Code, is
 1-33 amended to read as follows:

1-34 (b-3) This subsection and Subsection (b-2) expire August
 1-35 31, 2021 [~~2019~~].

1-36 SECTION 4. Section 502.358(c), Transportation Code, is
 1-37 amended to read as follows:

1-38 (c) This section expires August 31, 2021 [~~2019~~].

1-39 SECTION 5. The heading to Section 548.5055, Transportation
 1-40 Code, is amended to read as follows:

1-43 SECTION 6. Sections 548.5055(b) and (c), Transportation
 1-44 Code, are amended to read as follows:

 1-47 by the comptroller for deposit in the Texas emissions [~~emission~~]
 1-48 reduction plan fund.
