- (c-1) Eligibility to apply for set-aside funds under 21 Subsection (c) is determined by federal law [The following entities 22 are eligible to apply for set-aside funds under Subsection (c): 23

- (c-2) In allocating set-aside funds under Subsection (c),
- 4 the department:
- 5 (1) may not give preference to nonprofit providers of

- 18 SECTION 3. This Act takes effect September 1, 2019.
