#### A BILL TO BE ENTITLED

AN ACT

relating to the continuation and functions of the Texas Real Estate 2 3 Commission and the Texas Appraiser Licensing and Certification 4 Board; changing fees.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5

6 SECTION 1. Section 1101.006, Occupations Code, is amended to read as follows: 7

Sec. 1101.006. APPLICATION OF SUNSET ACT. The Texas Real 8 Estate Commission is subject to Chapter 325, Government Code (Texas 9 Sunset Act). Unless continued in existence as provided by that 10 chapter, the commission is abolished and this chapter, Chapter 11 12 1102, and Chapter 1303 of this code and Chapter 221, Property Code, 13 expire September 1, 2025 [2019].

SECTION 2. Section 1101.059, Occupations Code, is amended 14 15 by amending Subsections (b) and (c) and adding Subsection (d) to read as follows: 16

17 (b) The training program must provide the person with information regarding: 18

(c) A person appointed to the commission is entitled to
reimbursement, as provided by the General Appropriations Act, for
the travel expenses incurred in attending the training program

The executive director shall distribute a copy of 6 the training manual annually to each member of the commission.  23 education course of study[+

24 [(3) an application for approval of an instructor of

The denial of an approval under this subsection is subject to the same provisions 14 15 as are applicable under Section 1101.364 to the denial of a license. 16 SECTION 8. Section 1101.303, Occupations Code, is amended by adding Subsections (c) and (d) to read as follows: 17 18 (c) The commission may by rule develop minimum education and experience requirements for an instructor of a continuing education 19 course of study. For commission approval of an application to offer 20 the course, the applicant must ensure that the course's instructors 21 22 meet the minimum education and experience requirements developed by 23 the commission under this subsection. (d) The commission may deny an application to renew an 24 25 approval under this section if the applicant is in violation of a commission order. The denial of an approval under this subsection 26 27 is subject to the same provisions as are applicable under Section
