## A BILL TO BE ENTITLED

AN ACT

2 relating to prohibiting the use of certain aversive techniques on

- 3 students enrolled in public schools.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 37, Education Code, is
- 6 amended by adding Section 37.0023 to read as follows:
- 7 Sec. 37.0023. PROHIBITED AVERSIVE TECHNIQUES. (a) In this
- 8 section, "aversive technique" means a technique or intervention
- 9 that is intended to reduce the likelihood of a behavior reoccurring
- 10 by intentionally inflicting on a student significant physical or
- 11 <u>emotional discomfort or pain. The term includes a technique or</u>
- 12 <u>intervention that:</u>
- 13 (1) is designed to or likely to cause physical pain,
- 14 other than an intervention or technique permitted under Section
- 15 37.0011;

- 16 (2) notwithstanding Section 37.0011, is designed to or
- 17 <u>likely to cause physical pain through the use of electric</u> shock or
- 18 any procedure that involves the use of pressure points or joint
- 19 locks;
- 20 (3) involves the directed release of a noxious, toxic,
- 21 or otherwise unpleasant spray, mist, or substance near the
- 22 student's face;
- 23 (4) denies adequate sleep, air, food, water, shelter,
- 24 bedding, physical comfort, or access to a restroom facility;

1	(5) ridicules or demeans the student in a manner that
2	adversely affects or endangers the learning or mental health of the
3	student or constitutes verbal abuse;
4	(6) employs a device, material, or object that
5	simultaneously immobilizes all four extremities, including any
6	procedure that results in such immobilization known as prone or
7	<pre>supine floor restraint;</pre>
8	(7) impairs the student's breathing, including any
9	<pre>procedure that involves:</pre>
10	(A) applying pressure to the student's torso or
11	neck; or
12	(B) obstructing the student's airway, including
13	placing an object in, on, or over the student's mouth or nose or
14	placing a bag, cover, or mask over the student's face;
15	(8) restricts the student's circulation;
16	(9) secures the student to a stationary object while
17	the student is in a sitting or standing position;
18	(10) inhibits, reduces, or hinders the student's
19	ability to communicate;
20	(11) involves the use of a chemical restraint;
21	(12) constitutes a use of timeout that precludes the
22	student from being able to be involved in and progress
23	appropriately in the required curriculum and, if applicable, toward
24	the annual goals included in the student's individualized education
25	program, including isolating the student by the use of physical
26	<pre>barriers; or</pre>
27	(13) except as provided by Subsection (c), deprives

- 1 the student of the use of one or more of the student's senses.
- 2 (b) A school district or school district employee or
- 3 volunteer or an independent contractor of a school district may not
- 4 apply an aversive technique, or by authorization, order, or
- 5 consent, cause an aversive technique to be applied, to a student.
- 6 (c) Notwithstanding Subsection (a)(13), an aversive
- 7 technique described by Subsection (a)(13) may be used if the
- 8 technique is executed in a manner that:
- 9 (1) does not cause the student discomfort or pain; or
- 10 (2) complies with the student's individualized
- 11 education program or behavior intervention plan.
- 12 (d) Nothing in this section may be construed to prohibit a
- 13 teacher from removing a student from class under Section 37.002.
- 14 (e) In adopting procedures under this section, the
- 15 commissioner shall provide guidance to school district employees,
- 16 volunteers, and independent contractors of school districts in
- 17 avoiding a violation of Subsection (b).
- SECTION 2. This Act applies beginning with the 2019-2020
- 19 school year.
- 20 SECTION 3. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2019.
