SECTION 2. Chapter 43, Parks and Wildlife Code, is amended 2 3 by adding Subchapter Y to read as follows:

SUBCHAPTER Y. MANAGED LANDS DEER PROGRAM 4 5 Sec. 43.975. DEFINITION. In this subchapter, "program" means the Managed Lands Deer Program described by 31 T.A.C. Section 6 7 65.29, or a successor to that program. Sec. 43.976. PROGRAM PARTICIPATION FEE. (a) 8 The commission by rule may impose a fee for participation in the 9 program. Section 2001.0045, Government Code, does not apply to a 10 rule adopted under this section. 11 (b) The commission shall remit a fee collected under 12 13 Subsection (a) to the comptroller for deposit to the credit of the game, fish, and water safety account. 14 Sec. 43.977. RULES. The commission shall adopt rules 15 16 required to implement the program. SECTION 3. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2019.
