- 4 Sec. 50D.005. STAFF. The board is administratively
- 5 attached to the department. The department shall provide the board
- 6 with the staff necessary to carry out the board's duties under this
- 7 chapter.
- 8 SECTION 2. As soon as practicable after the effective date
- 9 of this Act, the commissioner of agriculture shall appoint the
- 10 members of the Texas Olive Oil Industry Advisory Board as provided
- 11 by Chapter 50D, Agriculture Code, as added by this Act.
- 12 SECTION 3. This Act takes effect immediately if it receives
- 13 a vote of two-thirds of all the members elected to each house, as
- 14 provided by Section 39, Article III, Texas Constitution. If this
- 15 Act does not receive the vote necessary for immediate effect, this
- 16 Act takes effect September 1, 2019.
