8	2 COUNTY. (a) The registered voters of a tier 1 county may file a
9	petition with the commissioners court of the county requesting an
10	election in the county to determine whether the county should be
11	considered a tier 2 county for the purposes of this chapter. The
12	petition must contain the signatures of at least seven percent of
13	the registered voters of the county.
14	(b) The commissioners court of a county that receives a
15	petition for an election under Subsection (a) shall:
16	(1) verify the signatures on the petition; and
17	(2) if the county verifies that the petition satisfies
18	the signature requirement under Subsection (a):
19	(A) order the election; and
20	(B) provide notice of the verified petition as
21	soon as practicable to the governing body of each municipality:
22	(i) located wholly or partly in the county;
23	<u>or</u>
24	(ii) with extraterritorial jurisdiction in

- 5 SECTION 2. Section 43.0686(b), Local Government Code, is
- 6 amended to read as follows:
- 7 (b) If the municipality does not obtain the number of
- 8 signatures on the petition required to annex the area, the
- 9 municipality may not annex $\underline{any part of}$ the area and may not adopt
- 10 another resolution under Section 43.0682 to annex any part of the
- 11 area until the fifth [first] anniversary of the date the petition
- 12 period ended.
- SECTION 3. Section 43.0697(b), Local Government Code, is
- 14 amended to read as follows:
- 15 (b) If at the election held under this subchapter a majority
- 16 of qualified voters do not approve the proposed annexation, or if
- 17 the municipality is required to petition owners of land in the area
- 18 under Section 43.0695 and does not obtain the required number of
- 19 signatures, the municipality may not annex any part of the area and
- 20 may not adopt another resolution under Section 43.0692 to annex any
- 21 part of the area until the fifth [first] anniversary of the date of
- 22 the adoption of the resolution.
- SECTION 4. Section 43.001(3), Local Government Code, is
- 24 amended to read as follows:
- 25 (3) "Tier 2 county" means a county that [+
- [(A)] is not a tier 1 county[$\frac{1}{2}$ or
- 27 [(B) is a tier 1 county in which a majority of the

- 1 registered voters of the county have approved being a tier 2 county
- 2 at an election ordered by the commissioners court on the request by
- 3 petition of a number of registered voters of the county equal to or
- 4 greater than 10 percent of the registered voters of the county].
- 5 SECTION 5. This Act takes effect immediately if it receives
- 6 a vote of two-thirds of all the members elected to each house, as
- 7 provided by Section 39, Article III, Texas Constitution. If this
- B Act does not receive the vote necessary for immediate effect, this
- 9 Act takes effect September 1, 2019.
