- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Chapter 79, Civil Practice and Remedies Code, is
- 7 amended by adding Section 79.0031 to read as follows:
- 8 Sec. 79.0031. LIABILITY OF VOLUNTEER HEALTH CARE PROVIDER
- 9 OR HEALTH CARE INSTITUTION. (a) In this section:
- 10 (1) "Health care institution" has the meaning assigned
- 11 by Section 74.001.
- 12 (2) "Volunteer health care provider" has the meaning
- 13 assigned by Section 84.003. The term includes an individual who is
- 14 <u>not affiliated with a charitable organization.</u>
- 15 (b) Except in the case of reckless conduct or intentional,
- 16 wilful, or wanton misconduct, a volunteer health care provider is
- 17 immune from civil liability for an act or omission that occurs in
- 18 giving care, assistance, or advice if the care, assistance, or
- 19 advice is provided:
- 20 (1) in relation to an incident that is a man-made or
- 21 <u>natural disaster that endangers or threatens to endanger</u>
- 22 individuals, property, or the environment; and
- 23 (2) within the scope of the provider's practice under
- 24 the laws of this state.

- 1 (c) A health care institution is immune from civil liability
- 2 for an act or omission by a volunteer health care provider providing
- 3 care, assistance, or advice at the institution's facility or under
- 4 the institution's direction if:
- 5 (1) the provider is immune from civil liability under
- 6 Subsection (b); and
- 7 (2) the institution does not have an expectation of
- 8 compensation from or on behalf of the recipient of the care,
- 9 <u>assistance</u>, or advice in excess of reimbursement for expenses
- 10 incurred by the institution in connection with the provision of the
- 11 care, assistance, or advice.
- 12 (d) The immunity provided by this section is in addition to
- 13 any other immunity or limitations of liability provided by law.
- 14 SECTION 2. Section 79.0031, Civil Practice and Remedies
- 15 Code, as added by this Act, does not apply to a cause of action that
- 16 accrued before the effective date of this Act.
- 17 SECTION 3. This Act takes effect September 1, 2019.
