A BILL TO BE ENTITLED

1 AN ACT relating to local school health advisory councils and health 2 3 education provided by school districts, including requirements 4 regarding human sexuality instruction. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Section 28.004, Education Code, is amended by 6 amending Subsections (d), (d-1), (h), (i), (i-1), and (j) and 7 8 adding Subsections (e-1) and (e-2) to read as follows: The local school health advisory council must consist of 9 (d) 10 at least five members, with each member appointed by the [The] board of trustees [shall appoint at least five members to the local school 11 12 health advisory council]. A majority of the members must be persons 13 who are parents of students enrolled in the district and who are not employed by the district. One of those members shall serve as chair 14 15 or co-chair of the council. The board of trustees also may appoint one or more persons from each of the following groups or a 16 17 representative from a group other than a group specified under this subsection: 18 19 (1)public school teachers; public school administrators; 20 (2) district students; (3) 21 22 (4)health care professionals; (5) the business community; 23

senior citizens; 1 (7) 2 (8) the clergy; nonprofit health organizations; and 3 (9) 4 local domestic violence programs. (d-1) The local school health advisory council shall meet at 5 least four times each year and promptly submit the minutes of each 6 7 meeting to the school district. As soon as practicable after receipt of minutes under this subsection, the district shall post 8 9 the minutes on the district's Internet website, if the district has an Internet website. 10 11 (e-1) The board of trustees shall adopt a policy 12 establishing a process for the adoption of curriculum or curriculum 13 materials for the district's human sexuality instruction. policy must require: 14 15 (1) the board to adopt a resolution convening the 16 local school health advisory council for the purpose of making recommendations regarding the curriculum or curriculum materials; 17 18 (2) the local school health advisory council to: (A) after the board's adoption of the resolution 19 under Subdivision (1), hold at least two public meetings, at which 20 an opportunity for public comment is provided, on the curriculum or 21 curriculum materials before adopting recommendations; and 22 23 (B) provide the recommendations adopted under Paragraph (A) to the board at a public meeting of the board, at 24 25 which an opportunity for public comment is provided; and (3) the board, after receipt of the local school 26

health advisory council's recommendations under Subdivision (2),

- 9 (h) The board of trustees shall determine the specific
- 10 content of the district's instruction in human sexuality, in
- 11 accordance with this section [Subsections (e), (f), and (g)].
- 12 (i) Before each school year, a school district shall provide
- 13 written notice to a parent of each student enrolled in the district
- 14 of the board of trustees' decision regarding whether the district
- 15 will provide human sexuality instruction to district students. If
- 16 instruction will be provided, the notice must include:
- 17 (1) a summary of the basic content of the district's
- 18 human sexuality instruction to be provided to the student,
- 19 including a statement informing the parent of the instructional
- 20 requirements under state law;
- 21 (2) each date on which the district's human sexuality
- 22 instruction will be provided to the student along with a detailed
- 23 <u>description of the content of the instruction to be provided on that</u>
- 24 <u>date;</u>
- 25 <u>(3)</u> a statement of the parent's right to:
- 26 (A) receive a copy of [review] curriculum
- 27 materials as provided by Subsection (j); [and]

- 1 (B) remove the student from any part of the
- 2 district's human sexuality instruction without subjecting the
- 3 student to any disciplinary action, academic penalty, or other
- 4 sanction imposed by the district or the student's school; and
- 5 (C) use the grievance procedure as provided by
- 6 Subsection (i-1) or the appeals process under Section 7.057
- 7 concerning a complaint of a violation of this section;
- 8 <u>(4) a statement that the curriculum materials for the</u>
- 9 district's human sexuality instruction must be posted on the
- 10 district's Internet website and the Internet website address at
- 11 which the curriculum materials are located; and
- 12 (5) [(3)] information describing the opportunities
- 13 for parental involvement in the development of the curriculum to be
- 14 used in human sexuality instruction, including information
- 15 regarding the local school health advisory council established
- 16 under Subsection (a).
- 17 (i-1) A parent may use the grievance procedure adopted under
- 18 Section 26.011 concerning a complaint of a violation of this
- 19 section [Subsection (i)].
- 20 (j) A school district shall:
- 21 (1) on request by a parent of a student enrolled in the
- 22 district, provide by mail or e-mail to the parent a copy of [make]
- 23 all curriculum materials used in the district's human sexuality

- 25 (2) post on the district's Internet website all
- 26 <u>curriculum materials used in the district's human sexuality</u>
- 27 instruction [available for reasonable public inspection].

- 20 as added by this Act, and Section 28.004(h), Education Code, as
- 21 amended by this Act, apply beginning with the 2020-2021 school
- 22 year.
- 23 SECTION 6. (a) Section 551.001, Government Code, as
- 24 amended by this Act, applies only to a meeting held on or after
- 25 September 1, 2019. A meeting held before September 1, 2019, is
- 26 governed by the law in effect immediately before September 1, 2019,
- 27 and the former law is continued in effect for that purpose.

- 1 (b) Section 552.003, Government Code, as amended by this
 2 Act, applies only to a request for public information received on or
 3 after September 1, 2019. A request for public information received
 4 before September 1, 2019, is governed by the law in effect when the
 5 request was received, and the former law is continued in effect for
 6 that purpose.
- SECTION 7. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.
