## A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the name of the Southwest Collegiate Institute for the
- 3 Deaf.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 131, Education Code, is amended to read
- 6 as follows:
- 7 CHAPTER 131. SOUTHWEST  $\underline{\text{CO}}$ LLEGE [ $\underline{\text{COLLEGIATE INSTITUTE}}$ ] FOR THE DEAF
- 8 Sec. 131.001. SOUTHWEST <u>COLLEGE</u> [<del>COLLEGIATE INSTITUTE</del>] FOR
- 9 THE DEAF. The Southwest College [Collegiate Institute] for the
- 10 Deaf is a postsecondary educational institution providing
- 11 instruction for hearing-impaired students preparing for a career or
- 12 for enrollment in a senior college or university.
- 13 Sec. 131.002. ADMINISTRATION. (a) The <u>college</u>
- 14 [institute] is under the direct control and management of the board
- 15 of trustees of the Howard Junior College District.
- 16 (b) The college [institute] and its programs shall be
- 17 administered by personnel who are trained and qualified to work
- 18 with hearing-impaired students and are fluent in manual
- 19 communication skills.
- Sec. 131.003. LOCATION. The <u>college</u> [<u>institute</u>] is located
- 21 on land deeded to the governing board by the federal Department of
- 22 Education for the purpose of operating the college [institute].
- 23 The governing board may not conduct regular junior college programs
- 24 for students with unimpaired hearing on the college [institute]

- 1 campus except as an integral part of the program offered to
- 2 hearing-impaired students when:
- 3 (1) it is educationally appropriate to enroll hearing
- 4 students in classes for the hearing-impaired; or
- 5 (2) special programs are needed to train hearing and
- 6 hearing-impaired persons to become professional service providers
- 7 for the deaf.
- 8 Sec. 131.004. COURSES, PROGRAMS, AND SERVICES. (a) The
- 9 college [institute] shall offer, but is not limited to offering,
- 10 the following courses, programs, and services for hearing-impaired
- 11 post-secondary students:
- 12 (1) learning development services, including academic
- 13 counseling, tutorial services, reading instruction, services to
- 14 counter learning disabilities, and library-related services;
- 15 (2) communications services, including interpreters
- 16 for academic and nonacademic functions, speech therapy, and
- 17 auditory evaluation and training;
- 18 (3) academic college preparatory courses;
- 19 (4) career analysis services designed to assist each
- 20 student in identifying a career interest, considering the student's
- 21 aptitudes, abilities, and skills;
- 22 (5) regular college courses, including vocational and
- 23 technical education and liberal arts courses;
- 24 (6) extracurricular activities, including intramural
- 25 athletics; and
- 26 (7) postgraduation services, including job placement
- 27 services and services designed to orient employers to

- 1 hearing-impaired workers.
- 2 (b) The course work offered by the <u>college</u> [institute] shall
- 3 emphasize self-contained classrooms with instruction conducted by
- 4 instructors who are trained and qualified to work with
- 5 hearing-impaired students and are fluent in manual communication
- 6 skills. Hearing-impaired students may enroll in integrated classes
- 7 that are regular classes offered to students with unimpaired
- 8 hearing enrolled in the junior college.
- 9 (c) The programs, services, and facilities of the college
- 10 [institute] shall be designed to be appropriate to the needs of
- 11 hearing-impaired students.
- 12 (d) The executive director shall determine which courses
- 13 offered by the college [institute] are appropriate for an
- 14 electronic display on a screen or terminal, with less than 30
- 15 seconds delay, of a speaker's spoken message. The college
- 16 [institute] shall implement the electronic display in those
- 17 courses.
- 18 Sec. 131.005. TUITION. (a) A Texas resident student
- 19 enrolled in the college [institute] is exempt from tuition fees
- 20 under Section 54.364.
- 21 (b) A student who is not a resident of Texas shall pay
- 22 tuition at a rate that is the lesser of:
- (1) the rate provided by this code for a nonresident
- 24 student enrolled at a general academic teaching institution; or
- 25 (2) a rate determined by the board of trustees and the
- 26 Texas Higher Education Coordinating Board[, Texas College and
- 27 University System] to be the approximate cost to the college

- 1 [institute], not including room and board, of educating a student
- 2 during the academic year beginning the next fall.
- 3 Sec. 131.006. APPROPRIATIONS; GRANTS. (a) The governing
- 4 board of the college [institute] may receive appropriations for the
- 5 <u>college's</u> [<u>institute's</u>] operations only if the board operates the
- 6 college [institute] in compliance with this chapter.
- 7 (b) The board may accept gifts, grants, or donations of
- 8 money or property given to the college [institute] for the
- 9 <u>college's</u> [<u>institute's</u>] exclusive use in carrying out the purposes
- 10 of this subchapter.
- 11 (c) The board may expend appropriated funds for maintenance
- 12 and operation, including the maintenance and operation of student
- 13 housing and food service, unless the funds are specifically
- 14 restricted to another purpose by the appropriation.
- SECTION 2. Section 51.911(a)(1), Education Code, is amended
- 16 to read as follows:
- 17 (1) "Institution of higher education" has the meaning
- 18 assigned by [Subdivision (7) of] Section 61.003 of this code, but
- 19 includes the Southwest College [Collegiate Institute] for the Deaf
- 20 and Texas State Technical College System [Institute].
- 21 SECTION 3. Section 51.925(b), Education Code, is amended to
- 22 read as follows:
- 23 (b) In this section, "institution of higher education" has
- 24 the meaning assigned by [Subdivision (7) of] Section 61.003 of this
- 25 code, except that the term includes the Southwest College
- 26 [Collegiate Institute] for the Deaf and Texas State Technical
- 27 College System [Institute].

- 1 SECTION 4. Section 54.364(a)(5), Education Code, is amended
- 2 to read as follows:
- 3 (5) "Institution of higher education" has the meaning
- 4 assigned by Section 61.003, except that the term includes the
- 5 Southwest College [Collegiate Institute] for the Deaf.
- 6 SECTION 5. Section 31.001(8), Natural Resources Code, is
- 7 amended to read as follows:
- 8 (8) "Institution of higher education" means the Texas
- 9 State Technical College System, the Southwest College [Collegiate
- 10 Institute for the Deaf, or an institution of higher education,
- 11 excluding a public junior college, as defined by Section 61.003,
- 12 Education Code.
- 13 SECTION 6. (a) The name of the Southwest Collegiate
- 14 Institute for the Deaf is changed to the Southwest College for the
- 15 Deaf.
- 16 (b) A reference in law to the Southwest Collegiate Institute
- 17 for the Deaf means the Southwest College for the Deaf.
- 18 (c) An appropriation for the use or benefit of the Southwest
- 19 Collegiate Institute for the Deaf is available for the use and
- 20 benefit of the Southwest College for the Deaf.
- 21 SECTION 7. This Act takes effect September 1, 2019.
