BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 36.066(g), Water Code, is amended to 1-21 read as follows:

SECTION 3. Section 36.066(h), Water Code, is repealed. SECTION 4. An action that is filed before the effective date of this Act is governed by the law applicable to the action immediately before the effective date of this Act, and that law is continued in effect for that purpose. 1-46 1-47 1-48 1-49
