## A BILL TO BE ENTITLED

1	AN ACT
2	relating to a study of costs associated with dual credit courses
3	offered at public high schools.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 28, Education Code, is
6	amended by adding Section 28.0091 to read as follows:
7	Sec. 28.0091. STUDY OF COSTS OF DUAL CREDIT COURSES.
8	(a) The agency shall conduct an ongoing study to examine costs
9	associated with dual credit courses offered at public high schools.
10	In conducting the study, the agency shall:
11	(1) collect from school districts, public
12	institutions of higher education, and the Texas Higher Education
13	Coordinating Board data relating to costs associated with dual
14	credit courses, including:
15	(A) tuition and required fees;
16	(B) the cost of required textbooks or other
17	instructional materials;
18	(C) the cost of student transportation to and
19	from the location at which a dual credit course is provided;
20	(D) any fee collected to pay the instructor of a
21	dual credit course;
22	(E) the cost of any assessment instrument
23	administered under Section 51.333 as a prerequisite for enrollment
24	in a dual credit course;

1	(F) the cost of using a facility at which a dual
2	credit course is provided; and
3	(G) any other associated costs identified during
4	the study;
5	(2) identify the sources of funding for dual credit
6	courses and the amount funded by each source; and
7	(3) consult with relevant stakeholders, including the
8	Texas Higher Education Coordinating Board, the American Institutes
9	for Research, and the Texas Dual Credit Task Force.
10	(b) The agency may contract with any public or private
11	entity to conduct the study under this section.
12	(c) Not later than December 1 of each even-numbered year,
13	the agency shall submit to the governor, the lieutenant governor,
14	and the speaker of the house of representatives a report on the
15	results of the study under this section. The report must include a
16	<pre>comparison of:</pre>
17	(1) costs associated with dual credit courses offered
18	at public high schools generally and costs associated with dual
19	credit courses offered through a college and career readiness
20	school program, including:
21	(A) an early college high school program;
22	(B) the Pathways in Technology Early College High
23	School (P-TECH) program established under Section 29.553;
24	(C) an Industry Cluster Innovative Academy; and
25	(D) a Texas Science, Technology, Engineering,
26	and Mathematics (T-STEM) Center; and
27	(2) the cost associated with dual credit courses per

1 semester credit hour or the equivalent and the total cost
2 associated with those courses.

3 (d) The commissioner may adopt rules as necessary to 4 administer this section.

5 SECTION 2. Not later than December 1, 2020, the Texas 6 Education Agency shall submit the initial report required under 7 Section 28.0091, Education Code, as added by this Act.

SECTION 3. The Texas Education Agency is required 8 to 9 implement a provision of this Act only if the legislature 10 appropriates money specifically for that purpose. If the 11 legislature does not appropriate money specifically for that purpose, the Texas Education Agency may, but is not required to, 12 implement a provision of this Act using other appropriations 13 available for that purpose. 14

15 SECTION 4. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2019.
