- SECTION 5.01. Chapter 54, Government Code, is amended by
- 23 adding Subchapter B to read as follows:
- 24 <u>SUBCHAPTER B. BELL COUNTY TRUANCY MASTERS</u>
- Sec. 54.101. APPOINTMENT. (a) The Commissioners Court of
- 26 Bell County may select masters to serve the justice courts of Bell
- 27 County having jurisdiction in truancy matters.

- 1 (b) The commissioners court shall establish the minimum
- 2 qualifications, salary, benefits, and other compensation of each
- 3 master position and shall determine whether the position is
- 4 full-time or part-time.

- 27 attorney, party, witness, or any other person fails to comply with a

- 1 summons or order, the master may certify that failure in writing to
- 2 the referring court for appropriate action.
- 3 Sec. 54.107. WITNESSES. (a) A witness appearing before a
- 4 master is subject to the penalties of perjury as provided by Chapter
- 5 37, Penal Code.

- 5 <u>(3)</u> be at least 30 years of age.
- 6 (b) A magistrate appointed under Section 54.2101 must take
- 7 the constitutional oath of office required of appointed officers of
- 8 this state.
- 9 Sec. 54.2103. COMPENSATION. (a) A magistrate is entitled
- 10 to the salary determined by the Commissioners Court of Kerr County.
- 11 (b) A full-time magistrate's salary may not be less than
- 12 that of a justice of the peace of Kerr County as established by the
- 13 annual budget of Kerr County.
- 14 <u>(c) A part-time magistrate's salary is equal to the per-hour</u>
- 15 salary of a justice of the peace. The per-hour salary is determined
- 16 by dividing the annual salary by a 2,000 work-hour year. The local

- 18 shall approve the number of hours for which a part-time magistrate
- 19 is to be paid.
- 20 (d) The magistrate's salary is paid from the county fund
- 21 available for payment of officers' salaries.

- 23 judicial immunity as a district judge.
- Sec. 54.2105. TERMINATION OF EMPLOYMENT. (a) A magistrate
- 25 may be terminated by a majority vote of all the judges of the
- 26 district and statutory county courts of Kerr County.
- 27 (b) To terminate a magistrate's employment, the local

administrative judge of the district courts serving Kerr County 1 must sign a written order of termination. The order must state: 2 3 (1) the magistrate's name; and 4 (2) the final date of the magistrate's employment. Sec. 54.2106.
