 SECTION 4. Section 31.048(c), Election Code, is amended to

4 SECTION 8. Section 31.170(c), Election Code, is amended to 5 read as follows:

6 (c) Not later than the third day after the date an order 7 abolishing the position of joint elections administrator is 8 adopted, the county clerk of the most populous participating county 9 shall deliver a certified copy of the order to the secretary of 10 state [and comptroller].

SECTION 9. The changes in law made by this Act apply only to an order adopted on or after the effective date of this Act. An order adopted before the effective date of this Act is governed by the law in effect on the date the order was adopted, and the former law is continued in effect for that purpose.

SECTION 10. This Act takes effect September 1, 2019.
