A BILL TO BE ENTITLED

1 AN ACT relating to updating references to certain former health services 2 state agencies and certain terms used to describe persons with 3 4 intellectual or developmental disabilities in the Education Code. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Section 25.041, Education Code, is amended to 6 7 read as follows: Sec. 25.041. TRANSFER OF CHILDREN OR WARDS OF EMPLOYEES OF 8 STATE <u>SUPPORTED LIVING CENTERS</u> [SCHOOLS]. A school-age child or 9 10 ward of an employee of a state supported living center [school] for persons with intellectual disabilities [the mentally retarded] 11

- constituted as a school district who resides in the boundaries of center [the state school] property but who is not a student at the center [state school] is entitled to attend school in a district adjacent to the center [state school] free of any charge to the child's or ward's parent or guardian provided the parent or guardian
- 17 is required by the superintendent of the <u>center</u> [state school] to
- 18 live on the grounds of the <u>center</u> [state school] for the convenience
- 19 of this state. A tuition charge required by the admitting district
- 20 shall be paid by the district constituting the state $\underline{\text{supported}}$
- 21 <u>living center</u> [school] out of funds allotted to it by the agency.

- 13 Not later than December 1 of each year, a school district that receives an allotment under this section shall submit 14 a report accounting for the expenditure of funds received under 15 16 this section to the governor, the lieutenant governor, the speaker of the house of representatives, the chairs of the standing 17 committees of the senate and house of representatives with primary 18 jurisdiction regarding persons with intellectual and developmental 19 20 disabilities [mental retardation] and public education, and each 21 member of the legislature whose district contains any portion of the territory included in the school. 22
- 23 SECTION 6. Section 30.0015(b), Education Code, is amended 24 to read as follows:
- 25 (b) The agency by rule shall develop and annually 26 disseminate standards for a school district's transfer of an 27 assistive technology device to an entity listed in this subsection

- 1 when a student with a disability using the device changes the school
- 2 of attendance in the district or ceases to attend school in the
- 3 district that purchased the device and the student's parents, or
- 4 the student if the student has the legal capacity to enter into a
- 5 contract, agrees to the transfer. The device may be transferred to:
- 6 (1) the school or school district in which the student

- 13 SECTION 9. Section 73.403, Education Code, is amended to
- 14 read as follows:
- 15 Sec. 73.403. OPERATION OF COMMITMENT CENTER. Harris
- 16 County, the Harris Center for Mental Health and IDD, or both of
- 17 those entities, [and/or the Mental Health and Mental Retardation
- 18 Authority (MHMRA) of Harris County | may operate on the premises of
- 19 the Harris County Psychiatric Center a commitment center, the
- 20 functions of which may include patient screening, intake, and
- 21 admissions (both voluntary and involuntary) to the Harris County
- 22 Psychiatric Center as may be provided for in a lease [and/or
- 23 sublease] and operating agreement or a sublease and operating
- 24 <u>agreement</u> as authorized under Section 73.405 [of this code]. The
- 25 functions of the Harris County Psychiatric Commitment Center
- 26 located on the premises of the Harris County Psychiatric Center
- 27 both in terms of operation and in terms of funding shall not be the

- 1 responsibility of the Health and Human Services Commission [Texas
- 2 Department of Mental Health and Mental Retardation] or The
- 3 University of Texas System. As may be provided for in a lease
- 4 [and/or sublease] and operating agreement or a sublease and
- 5 operating agreement, The University of Texas System may charge for
- 6 any support services provided by the Harris County Psychiatric
- 7 Center to the commitment center.
- 8 SECTION 10. Section 73.404, Education Code, is amended to
- 9 read as follows:

- Sec. 73.404. FUNDING. (a) Funding for the state-supported
- 11 facilities and operations of the Harris County Psychiatric Center
- 12 shall be provided through legislative appropriations to the <u>Health</u>
- 13 and Human Services Commission [Texas Department of Mental Health
- 14 and Mental Retardation] and to The University of Texas System, and
- 15 any appropriations to the <u>commission</u> [department] for the Harris
- 16 County Psychiatric Center shall be transferred to The University of
- 17 Texas System in accordance with the General Appropriations Act and
- 18 the lease [$\frac{\text{and}}{\text{or sublease}}$] and operating agreement $\frac{\text{or sublease}}{\text{or sublease}}$
- 19 <u>operating agreement</u> provided for in Section 73.405 [of this code].

Legislative appropriations may be for any further construction at

- 21 the Harris County Psychiatric Center; for equipment, both fixed
- 22 and movable; for utilities, including data processing and
- 23 communications; for maintenance, repairs, renovations, and
- 24 additions; for any damage or destruction; and for operations of
- 25 the Harris County Psychiatric Center; provided, however, that as
- 26 to funding for Harris County Psychiatric Center operations,
- 27 legislative appropriations shall not exceed 85 percent of the total

operating costs of the entire Harris County Psychiatric Center, exclusive of any costs of the commitment center.

(b) Any funding, under a lease [and/or sublease] 3 4 operating agreement or sublease and operating agreement wherein The University of Texas System is the lessee, for [the county-supported 5 and/or MHMRA-supported] facilities and operations of the Harris 6 7 County Psychiatric Center supported by the county or the Health and Human Services Commission, which may be provided through county 8 9 appropriations, including funds made available by the Harris Center for Mental Health and IDD [County Mental Health and Mental 10 11 Retardation Authority], or from gifts and grants, shall be transferred in accordance with the lease [and/or sublease] and 12 13 operating agreement or sublease and operating agreement provided for in Section 73.405 [of this code]. Such funds may be for any 14 15 further construction at the Harris County Psychiatric Center; 16 equipment, both fixed and movable; for utilities, including data communications; for maintenance, 17 processing and repairs, renovations, and additions; for any damage or destruction; and for 18 Harris County Psychiatric Center operations which latter funding 19 20 may be proportional to the total costs of The University of Texas System operating the entire Harris County Psychiatric Center, 21 22 exclusive of any additional cost incurred by [of] Harris County or the Health and Human Services Commission for [and/or MHMRA] 23 operating the commitment center, which costs shall remain the sole 24 25 responsibility of the entity or entities that incurred those costs [Harris County and/or MHMRA]. 26

27 SECTION 11. Sections 73.405(a) and (d), Education Code, are

1 amended to read as follows:

- (a) The state-supported facilities of the Harris County 2 Psychiatric Center shall be leased to and operated and administered 3 4 by The University of Texas System in accordance with a lease and The 5 operating agreement. [county-supported and/or MHMRA-supported] facilities supported by the county or the Harris 6 7 Center for Mental Health and IDD, exclusive of the commitment center, may be leased or [and/or] subleased by The University of 8 9 Texas System in the same lease [and/or sublease] and operating agreement or sublease and operating agreement. Any lease [and/or 10 11 sublease] and operating agreement or sublease and operating agreement shall provide for a lease payment by The University of 12 13 Texas System of no more than \$1 per year plus other good and valuable consideration as provided for in Section 73.406 [of this 14 15 code].
- 16 Any lease [and/or sublease] and operating agreement or <u>sublease and operating agreement</u> shall provide that The University 17 of Texas System shall cause the Harris County Psychiatric Center to 18 be operated in accordance with the standards for accreditation of 19 20 The [the] Joint Commission [on Accreditation of Hospitals]; that all financial transactions and performance programs may be 21 appropriately audited; that an admission, discharge, and transfer 22 coordination policy be established; that appropriate patient data 23 24 be made available to the <u>Health and Human Services Commission</u>, the 25 Harris Center for Mental Health and IDD [department, MHMRA], and the county, including but not limited to diagnosis and lengths of 26 27 stay; and that a priority of patient treatment policy be

- 1 established.
- 2 SECTION 12. Section 73.406, Education Code, is amended to
- 3 read as follows:
- 4 Sec. 73.406. REVENUES. That portion of any revenues
- 5 related to the provision of patient services through the operation
- 6 of the Harris County Psychiatric Center facilities that are leased
- 7 or [and/or] subleased by and to The University of Texas System shall
- 8 be accounted for and expended in accordance with the rules,
- 9 regulations, and bylaws of The University of Texas System and in
- 10 such manner that such revenues will reduce appropriated and funded
- 11 requirements by both the state and county or the Harris Center for
- 12 Mental Health and IDD [MHMRA] on a prorated basis, all as may be
- 13 provided for in a lease [and/or sublease] and operating agreement
- 14 or sublease and operating agreement.
- 15 SECTION 13. Section 73.501, Education Code, is amended to

- 17 Sec. 73.501. TRANSFER AND LEASE OF FACILITIES. (a) The
- 18 governance, operation, management, and control of the Texas
- 19 Research Institute of Mental Sciences [created by Chapter 427, Acts
- 20 of the 55th Legislature, Regular Session, 1957, as amended (Article
- 21 3174b-4, Vernon's Texas Civil Statutes), and all land, buildings,
- 22 improvements thereon, and major fixed equipment comprising said
- 23 institute shall be leased from the Health and Human Services
- 24 Commission or a former state agency that provided services to
- 25 persons with mental illness, persons with intellectual
- 26 disabilities, and persons with developmental disabilities [Texas
- 27 Department of Mental Health and Mental Retardation] and transferred

- 1 to the board of regents of The University of Texas System for \$1 a
- 2 year and shall be subject to the provisions of [Subdivision (9) of
- 3 Subsection (a) of Section 65.02(a)(9) [65.02 of the Education
- 4 Code].
- 5 (b) All land, buildings, and improvements thereon and major
- 6 fixed equipment comprising said institute leased by The University
- 7 of Texas System shall be utilized only for purposes of patient care
- 8 services, research, and education related to mental health,
- 9 <u>intellectual disability</u>, and <u>developmental disability</u> [mental
- 10 retardation]. The <u>Health and Human Services Commission or a former</u>
- 11 state agency that provided services to persons with mental illness,
- 12 persons with intellectual disabilities, and persons with
- 13 developmental disabilities [Texas Department of Mental Health and
- 14 Mental Retardation] may sell or otherwise dispose of the land,
- 15 buildings, improvements thereon, or major fixed equipment provided
- 16 that the proceeds from the sale or other disposition shall be used
- 17 for the same purposes in Harris County; and further provided, that
- 18 the board of regents of The University of Texas System, prior to
- 19 such sale or other disposition, has approved of such sale or
- 20 disposition and the allocation of proceeds.
- 21 SECTION 14. Section 73.502, Education Code, is amended to
- 22 read as follows:
- Sec. 73.502. TRANSFER OF GIFTS, GRANTS, UNEXPENDED
- 24 BALANCES, CONTRACTS, AND OBLIGATIONS. Any gifts, grants,
- 25 unexpended balances of appropriated or unappropriated funds, and
- 26 all movable equipment that was held by a former state agency that
- 27 provided services to persons with mental illness, persons with

intellectual disabilities, and persons with developmental 1 2 disabilities or that was transferred to the Health and Human Services Commission on dissolution of that former agency and was 3 held [the Texas Department of Mental Health and Mental Retardation] 4 for, on behalf of, or for the use and benefit of the Texas Research 5 Institute of Mental Sciences are hereby transferred to The 6 7 University of Texas System; provided, however, that all previously appropriated funds for statewide training of [department] 8 9 personnel and program evaluation by the institute shall be retained by the Health and Human Services Commission [department]. 10 11 contracts and written obligations of every kind and character entered into by a former state agency that provided services to 12 13 persons with mental illness, persons with intellectual disabilities, and persons with developmental disabilities [the 14 Texas Department of Mental Health and Mental Retardation] for and 15 16 on behalf of the Texas Research Institute of Mental Sciences are ratified, confirmed, and validated, and in all such contracts and 17 written obligations, the board of regents of The University of 18 Texas System is substituted in lieu and shall stand and act in place 19 20 and stead of the former state agency that provided services to persons with mental illness, persons with 21 intellectual disabilities, and persons with developmental disabilities [Texas 22 Department of Mental Health and Mental Retardation]; provided, 23 24 however, that an advisory committee shall be established with 25 regard to research protocols and the executive commissioner of the <u>Health and Human Services Commission</u> [department] shall be a 26 27 member; provided further, that The University of Texas System may

- 1 contract with the Department of State Health Services [department]
- 2 for continued extramural and other laboratory consultative
- 3 services. The Health and Human Services Commission [Texas
- 4 Department of Mental Health and Mental Retardation], Harris County,
- 5 and the [Mental Health and Mental Retardation Authority of] Harris
- 6 Center for Mental Health and IDD [County] shall provide for the
- 7 continuity of inpatient and outpatient care of the patients and
- 8 programs operated at the Texas Research Institute of Mental
- 9 Sciences and may contract for the provision of such services in
- 10 accordance with the provisions of and appropriations provided in
- 11 the General Appropriations Act.
- 12 SECTION 15. Sections 73.503(a) and (h), Education Code, are
- 13 amended to read as follows:
- 14 (a) Present institute personnel shall be allowed to apply
- 15 for employment with The University of Texas System, Harris County,
- 16 or the <u>Harris Center for Mental Health and IDD</u> [Mental Health and
- 17 Mental Retardation Authority of Harris County] and be given
- 18 priority consideration for such employment.
- 19 (h) The Employees Retirement System, the Health and Human
- 20 Services Commission [Texas Department of Mental Health and Mental
- 21 Retardation], and The University of Texas System shall provide the
- 22 Teacher Retirement System with information necessary to establish
- 23 employees' rights to credit under this section. The Employees
- 24 Retirement System and the Teacher Retirement System shall establish
- 25 procedures to prevent duplication of retirement credit for the same
- 26 service.
- 27 SECTION 16. This Act takes effect September 1, 2019.
