## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the advisory council on postsecondary 3 education for persons with intellectual and developmental disabilities. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Section 61.0663(b), Education Code, is amended to read as follows: 7 (b) The board shall: 8 9 (1)post the inventory on the board's Internet website in an easily identifiable and accessible location; 10 11 (2) submit the inventory to the Texas Education Agency 12 for inclusion in the transition and employment guide under Section 29.0112; and 13 14 (3) update the inventory at least annually [once every 15 two years]. SECTION 2. Subchapter C, Chapter 61, Education Code, is 16 amended by adding Section 61.06641 to read as follows: 17 18 Sec. 61.06641. ACCESS TO HIGHER EDUCATION FOR PERSONS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES; ADVISORY COUNCIL. 19 (a) The board, with the assistance of the advisory council 20 21 established under this section, shall: (1) periodically review the policies and practices 22 23 that increase access to higher education opportunities for persons with intellectual and developmental disabilities; and 24

2	developed by the advisory council to increase awareness regarding

5	(b) The board shall establish an advisory council on
6	postsecondary education for persons with intellectual and
7	developmental disabilities, in accordance with Section 61.026, to
8	advise the board on policies and practices to improve postsecondary
9	education opportunities for persons with intellectual and
10	developmental disabilities.
11	(c) The advisory council is composed of the following
12	members appointed as follows:
13	(1) one member appointed by the executive director of
14	the Texas Workforce Commission;
15	(2) one member appointed by the commissioner of the
16	Texas Education Agency;
17	(3) a representative of the continuing advisory
18	committee established under Section 29.006 appointed by the
19	governor; and
20	(4) the following members appointed by the board:
21	(A) a representative of a University Centers for
22	Excellence in Developmental Disabilities program in this state;
23	(B) a representative of a disability advocacy
24	group;
25	(C) a parent or guardian of a person with an
26	intellectual or developmental disability;
27	(D) a parent or guardian of a person with an

1 intellectual or developmental disability who is currently enrolled 2 in an institution of higher education; 3 (E) a person with an intellectual or developmental disability enrolled in an institution of higher 4 5 education; 6 (F) a person with an intellectual or 7 developmental disability who has completed a program at an institution of higher education; 8 9 (G) a high school counselor; 10 (H) a specialist in the transition to employment from a regional education service center, school district, or other 11 12 state agency; and (I) additional representatives with relevant 13 14 experience, as needed. 15 (d) Members of the advisory council serve two-year terms. 16 (e) A member of the advisory council is not entitled to 17 compensation but is entitled to reimbursement for actual and necessary expenses incurred by the member while conducting the 18 19 business of the advisory council. (f) The members of the advisory council shall elect a 20 presiding officer from among the membership. 21 22 (g) The advisory council shall: (1) study the accessibility of higher education for 23 24 persons with intellectual and developmental disabilities; 25 (2) provide advice regarding resolving barriers to 26 accessing higher education for persons with intellectual and 27 developmental disabilities; and

1	(3) identify, evaluate, and develop recommendations
2	to address barriers to accessing higher education for persons with
3	intellectual and developmental disabilities who are or have been in
4	the foster care system and any data collection issues in relation to
5	those persons.
6	(h) The advisory council shall meet at least quarterly at
7	the call of the presiding officer.
8	(i) Notwithstanding Chapter 551, Government Code, or any
9	other law, the advisory council may meet by telephone conference
10	call, videoconference, or other similar telecommunication method.
11	A meeting held by telephone conference call, videoconference, or
12	other similar telecommunication method is subject to the
13	requirements of Sections 551.125(c)-(f), Government Code.
14	(j) The advisory council shall submit a report to the board
15	annually, at a time determined by the board. The report must
16	include information regarding:
17	(1) the advisory council's activities;
18	(2) any relevant rule changes necessary to decrease
19	barriers to accessing higher education for persons with
20	intellectual and developmental disabilities; and
21	(3) recommendations for potential outreach and
22	education materials to increase public awareness of the
23	availability of higher education opportunities and resources for
24	persons with intellectual and developmental disabilities,
25	including information regarding available grants, loan programs,
26	and other resources that may require statewide outreach efforts.
27	(k) Not later than December 1 of each even-numbered year,

1 the advisory council shall provide a report to the board and to the governor, the lieutenant governor, the speaker of the house of 2 representatives, the members of the legislature, and, as necessary, 3 other state agencies or relevant stakeholders. The report must 4 5 include: 6 (1) historic and current higher education data and 7 related information regarding persons with intellectual and 8 developmental disabilities, including: 9 (A) graduation rates; (B) the geographic distribution of institutions 10 of higher education providing appropriate opportunities; 11 12 (C) a description of available programs; and (D) any other relevant data; and 13 14 (2) recommendations for changes to support success and 15 achievement for persons with intellectual and developmental disabilities in accessing higher education, including 16 17 recommendations for: (A) addressing gaps in data; and 18 19 (B) identifying problems with and barriers to accessing higher education. 20 21 (1) The board shall provide administrative support for the advisory council. 22 Not later than January 1, 2020, the SECTION 3. (a) 23 24 appropriate appointing authorities shall appoint the members to the advisory council on postsecondary education for persons with 25 26 intellectual and developmental disabilities as required by Section 61.06641, Education Code, as added by this Act. 27

1 (b) Not later than December 1, 2020, the advisory council on 2 postsecondary education for persons with intellectual and 3 developmental disabilities shall complete the initial reports 4 required under Sections 61.06641(j) and (k), Education Code, as 5 added by this Act.

6 SECTION 4. This Act takes effect immediately if it receives 7 a vote of two-thirds of all the members elected to each house, as 8 provided by Section 39, Article III, Texas Constitution. If this 9 Act does not receive the vote necessary for immediate effect, this 10 Act takes effect September 1, 2019.
