(a) The voter 8 9 registrar of each county shall automatically register any county resident who is 18 years of age, eligible to vote as provided by 10 Section 13.001, and issued a Texas driver's license or a personal 11 identification card by the Department of Public Safety. 12 (b) A driver's license or personal identification card 13 14 transaction with an indication provided by Section 20.063(c) that the transaction is not for voter registration purposes is not 15 16 subject to this section. SECTION 2. Section 20.061, Election Code, is amended to 17 read as follows: 18 Sec. 20.061. APPLICABILITY OF OTHER PROVISIONS. The other 19 provisions of this chapter apply to the Department of Public Safety 20 except provisions that conflict with this subchapter or Section 21 22 13.009. SECTION 3. Section 20.063, Election Code, is amended by 23 amending Subsections (a) and (c) and adding Subsection (e) to read 24 86R10150 JRJ-D 1

(a) The Department of Public Safety shall provide to each
person who applies in person, by mail, or online at the department's
<u>Internet website</u> [at the department's offices] for an original or
renewal of a driver's license, a personal identification card, or a
duplicate or corrected license or card an opportunity to complete a
voter registration application form.

8 (c) A change of address that relates to a license or card and that is submitted to the department in person, [or] by mail, or 9 online at the department's Internet website serves as a change of 10 address for voter registration unless the licensee or cardholder 11 indicates that the change is not for voter registration purposes. 12 The date of submission of a change of address to a department 13 14 employee is considered to be the date of submission to the voter registrar for the purpose of determining the effective date of 15 registration [only]. 16

17 (e) The Department of Public Safety shall consider an application made in person, by mail, or online at the department's 18 19 Internet website for an original or renewal of a driver's license, a personal identification card, or a duplicate or corrected license 20 or card by a person who is 18 years of age and eligible to vote as 21 provided by Section 13.001 an application for voter registration. 22 The date of application is considered to be the date of submission 23 24 to the voter registrar for the purpose of determining the effective date of registration. The registration of an eligible voter under 25 26 this subsection is automatic unless the person indicates that the transaction is not for voter registration purposes. 27

S.B. No. 1053 SECTION 4. Section 20.065(b), Election Code, is amended to read as follows: (b) Each weekday the department is regularly open for

4 business, the department shall electronically transfer to the 5 secretary of state the name <u>and information designated by the</u> 6 <u>secretary of state for</u> [of] each person who completes a voter 7 registration application submitted to the department <u>and for each</u> 8 <u>individual who is eligible for registration under Section</u> 9 <u>20.063(e)</u>. The secretary shall prescribe procedures necessary to 10 implement this subsection.
