4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 12, Health and Safety Code, is amended by
6	adding Subchapter K to read as follows:
7	SUBCHAPTER K. PUBLIC HEALTH LABORATORY CAPABILITIES IN CERTAIN
8	COUNTIES
9	Sec. 12.151. PUBLIC HEALTH LABORATORY REPORT. (a) Not
10	later than September 1, 2020, the department shall prepare and
11	submit a written or electronic report to the legislature on public
12	laboratories in this state's counties that are adjacent to an
13	international border. The report must include:
14	(1) information on the existing testing capabilities
15	of the public laboratories, focusing on clinical, environmental,
16	and zoonotic testing capabilities; and
17	(2) recommendations to increase the efficiency,
18	effectiveness, and productivity of the public laboratories through
19	administrative action and legislation.
20	(b) The department shall collaborate with local health
21	departments established under Subchapter D, Chapter 121, and public
22	and private testing laboratories to collect information and develop
23	recommendations for the report described by Subsection (a).
24	(c) This section expires September 1, 2021.

1	Sec. 12.152. LOCAL AGREEMENTS. Using available resources
2	and as determined appropriate by the department, the department
3	shall enter into agreements with institutions of higher education
4	as defined by Section 61.003, Education Code, and public and
5	private testing laboratories in this state to increase the
6	availability of public health laboratory services for local health
7	departments established under Subchapter D, Chapter 121, in
8	counties adjacent to an international border. The agreements must
9	establish protocols that:
10	(1) ensure confidentiality of the laboratory testing;
11	(2) require the testing procedures to satisfy state
12	standards for laboratory testing;
13	(3) provide cost-effective resources to the local
14	health departments to increase the availability of laboratory
15	testing in the border counties;
16	(4) enhance the laboratory testing capacity,
17	including testing of human and nonhuman specimens, in the border
18	counties; and
19	(5) ensure the efficiency, effectiveness, and
20	accuracy of laboratory test results.
21	Sec. 12.153. YEAR-ROUND ACCESS TO LABORATORY TESTING FOR
22	VECTOR-BORNE INFECTIOUS DISEASES. Using available resources and as
23	determined appropriate by the department, the department shall
24	support access to year-round laboratory testing for vector-borne
25	infectious diseases to record and address local outbreaks of
26	vector-borne infectious diseases in the counties of this state that
27	are most at risk for the year-round outbreaks, including Maverick,

1	Val Verde, Webb, Zapata, Starr, Hidalgo, Willacy, and Cameron
2	Counties. The department may make the access directly available or
3	through a local agreement entered into under Section 12.152. The
4	testing may include, as appropriate:
5	(1) arboviral testing;
6	(2) speciation testing;
7	(3) PCR testing;
8	(4) IgM testing;
9	(5) IgG testing; and
10	(6) any other testing the department determines
11	appropriate.
12	SECTION 2. The Department of State Health Services is
13	required to implement a provision of this Act only if the
14	legislature appropriates money specifically for that purpose. If
15	the legislature does not appropriate money specifically for that
16	purpose, the department may, but is not required to, implement a
17	provision of this Act using other appropriations available for that

18 purpose.
