- SECTION 2. Section 325.007, Government Code, is amended by 9
- adding Subsections (c) and (d) to read as follows: 10
- 11 (c) Before November 1 of the odd-numbered year before the
- 12 year in which a state agency subject to this chapter is to be
- abolished, the agency shall present to the commission a zero-based 13
- 14 budget for the state fiscal biennium that begins on the date the
- agency is scheduled to be abolished that contains: 15
- 16 (1) a description of the discrete activities the
- agency is charged with conducting or performing, together with a 17
- justification for each activity by reference to a statute or other 18
- 19 legal authority;
- 20 (2) for each activity identified under Subdivision
- (1): 21
- (A) a quantitative estimate of any adverse 22
- 23 effects that reasonably may be expected to result if the activity
- were discontinued, together with a description of the methods by 24

- 1 which the adverse effects were estimated;
- 2 (B) an itemized account of expenditures required
- 3 to maintain the activity at the minimum level of service or
- 4 performance required by the statute or other legal authority,
- 5 together with a concise statement of the quantity and quality of
- 6 service or performance required at that minimum level; and
- 7 (C) an itemized account of expenditures required
- 8 to maintain the activity at the current level of service or
- 9 performance, together with a concise statement of the quantity and
- 10 quality of service or performance provided at that current level;
- 11 and
- 12 (3) a ranking of activities identified under
- 13 <u>Subdivision (1) that illustrates the relative importance of each</u>
- 14 activity to the overall goals and purposes of the agency at current
- 15 service or performance levels.
- 16 (d) A state agency shall submit the zero-based budget
- 17 required under Subsection (c) to the Legislative Budget Board as
- 18 part of the agency's legislative appropriations request for the
- 19 state fiscal biennium that begins on the date the agency is
- 20 scheduled to be abolished.
- 21 SECTION 3. The changes in law made by this Act apply in
- 22 relation to the review by the Sunset Advisory Commission of
- 23 agencies scheduled to be abolished on or after September 1, 2023, if
- 24 not continued in accordance with Chapter 325, Government Code, and
- 25 in relation to any other agencies that by law are reviewed during
- 26 those review periods by the Sunset Advisory Commission.
- 27 SECTION 4. This Act takes effect September 1, 2019.
