3	developing a strategic plan to address those experiences.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 531, Government Code, is
6	amended by adding Section 531.0222 to read as follows:
7	Sec. 531.0222. COORDINATION TO ADDRESS ADVERSE CHILDHOOD
8	EXPERIENCES; STRATEGIC PLAN. (a) In this section, "adverse
9	<pre>childhood experience" includes:</pre>
10	(1) abuse as defined by Section 261.001, Family Code;
11	(2) neglect as defined by Section 261.001, Family
12	<pre>Code;</pre>
13	(3) family violence as defined by Section 71.004,
14	Family Code;
15	(4) intimate partner violence;
16	(5) parental separation or divorce; and
17	(6) substance use disorder, mental illness, or
18	incarceration of a member of a child's household.
19	(b) In order to reduce exposure of children in this state to
20	adverse childhood experiences and to address the social, health,
21	and economic impacts of those experiences, the commission, in
22	collaboration with the Department of Family and Protective
23	Services, the Department of State Health Services, the Texas
24	Education Agency, the Texas Workforce Commission, and an

- 2 Education Code, with expertise in addressing adverse childhood
- 3 experiences through a public health framework shall:
- 4 (1) analyze data related to the causes and effects of
- 5 adverse childhood experiences, including data from the Behavioral
- 6 Risk Factor Surveillance System established by the Centers for
- 7 <u>Disease Control and Prevention of the United States Public Health</u>
- 8 Service;
- 9 (2) evaluate prevention needs and gaps in services and
- 10 support regarding awareness of, screening for, and treatment of
- 11 adverse childhood experiences;
- 12 (3) identify methods to incorporate best practices for
- 13 preventing and treating adverse childhood experiences into
- 14 existing services and support programs offered for children and
- 15 <u>families; and</u>
- 16 (4) develop and implement a five-year strategic plan
- 17 to prevent and address adverse childhood experiences.
- 18 (c) In developing the five-year strategic plan under
- 19 Subsection (b)(4), the commission may collaborate with
- 20 <u>representatives of:</u>
- 21 (1) state and local agencies and nonprofit
- 22 <u>organizations that work directly with children and families;</u>
- 23 (2) child welfare services providers;
- 24 (3) early childhood education programs;
- 25 (4) public schools;
- 26 (5) medical and mental health services providers;
- 27 (6) social services providers;

1	(7) the law enforcement and criminal justice
2	community;
3	(8) faith-based organizations; and
4	(9) the business community.
5	(d) The strategic plan must incorporate a public health
6	approach that promotes collaboration between agencies and
7	community-based providers. The strategic plan may include
8	strategies to:
9	(1) train and educate professionals to assess, treat,
10	and prevent adverse childhood experiences;
11	(2) provide trauma-informed practices;
12	(3) provide high quality child care;
13	(4) provide support to parents to develop social and
14	economic independence;
15	(5) develop voluntary, evidence-based home visiting
16	programs specifically developed to meet the needs of women who are
17	pregnant and families with an infant to strengthen parenting skills
18	and the child's social and emotional development;
19	(6) develop parental support programs for teen parents
20	and young mothers;
21	(7) develop parental education training and
22	counseling programs;
23	(8) identify best practices for child protective
24	services;
25	(9) treat mental illness and substance use disorder;
26	and
27	(10) prevent intimate partner and family violence

- 1 (e) The commission shall publish the five-year strategic
- 2 plan required by Subsection (b) on the commission's Internet
- 3 website.
- 4 SECTION 2. Not later than December 1, 2020, the Health and
- 5 Human Services Commission shall:
- 6 (1) develop the five-year strategic plan required by
- 7 Section 531.0222(b)(4), Government Code, as added by this Act; and
- 8 (2) submit a report to the Senate Health and Human
- 9 Services Committee, the House Public Health Committee, and the
- 10 House Human Services Committee regarding the commission's
- 11 strategies for preventing and treating adverse childhood
- 12 experiences and any plan to incorporate those strategies into
- 13 existing services and support programs for children and families.
- SECTION 3. This Act takes effect September 1, 2019.
