- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 133, Education Code, is amended by
- 6 adding Section 133.010 to read as follows:
- 7 Sec. 133.010. WORK-BASED LEARNING TASK FORCE. (a) In this
- 8 section:

- 9 (1) "Agency" means the Texas Education Agency.
- 10 (2) "Coordinating board" means the Texas Higher
- 11 Education Coordinating Board.
- 12 (3) "Institution of higher education" has the meaning
- 13 assigned by Section 61.003.
- 14 (4) "Open-enrollment charter school" has the meaning
- 15 assigned by Section 5.001.
- 16 (5) "Task force" means the work-based learning task
- 17 force established under this section.
- 18 (6) "Work-based learning opportunity" includes a
- 19 youth or adult apprenticeship or internship that provides paid work
- 20 <u>experience</u> and corresponding classroom instruction, delivered in
- 21 an employment relationship that both the business and worker intend
- 22 to lead to an industry-recognized credential and full-time
- 23 employment after completion of the program.
- 24 (b) The work-based learning task force is established to

develop strategies for expanding and improving the delivery of 1 2 work-based learning opportunities in this state. (c) The task force is composed of the following 18 members: 3 (1) one member of the commission, appointed by the 4 executive director of the commission; 5 6 (2) one member of the coordinating board, appointed by 7 the commissioner of higher education; 8 (3) one member of the agency, appointed by the 9 commissioner of education; 10 (4) five members appointed by the governor as follows: 11 (A) one member from a school district or 12 open-enrollment charter school; 13 (B) one member from an institution of higher 14 education; 15 (C) two members from a high-growth, high-wage 16 industry; and 17 (D) one member from a statewide advocacy organization representing young adults, a statewide education 18 advocacy organization, or a student organization that focuses on 19 20 apprenticeships; (5) five members appointed by the lieutenant governor 21 22 as follows: 23 (A) one member from a school district or 24 open-enrollment charter school; 25 (B) one member from an institution of higher 26 education;

(C) two members from a high-growth, high-wage

- 2 (D) one member from a statewide advocacy
- 3 organization representing young adults, a statewide education
- 4 advocacy organization, or a student organization that focuses on
- 5 apprenticeships; and
- 6 (6) five members appointed by the speaker of the house
- 7 of representatives as follows:
- 8 (A) one member from a school district or
- 9 open-enrollment charter school;
- 10 (B) one member from an institution of higher
- 11 education;
- (C) two members from a high-growth, high-wage
- 13 industry; and
- 14 (D) one member from a statewide advocacy
- 15 organization representing young adults, a statewide education
- 16 advocacy organization, or a student organization that focuses on
- 17 <u>apprenticeships</u>.
- 18 (d) The members of the task force shall select a presiding
- 19 officer from among the membership.
- 20 (e) The task force shall meet at the call of the presiding
- 21 officer.
- 22 <u>(f) A member of the task force serves at the will of the</u>
- 23 member's appointing authority. A vacancy on the task force must be
- 24 filled in the same manner as the original appointment.
- 25 (g) A member of the task force may not receive compensation
- 26 for serving on the task force but is entitled to reimbursement for
- 27 travel expenses incurred by the member while conducting the

- 1 business of the task force as provided by the General
- 2 Appropriations Act.
- 3 (h) The commission, the coordinating board, and the agency
- 4 shall each provide necessary administrative and technical support
- 5 for the activities of the task force.
- 6 (i) The task force may solicit gifts, grants, and donations
- 7 from any public or private source for use in carrying out the task
- 8 force's duties under this section.
- 9 (j) The task force shall:
- 10 (1) develop recommendations for:
- 11 (A) increasing the number of work-based learning
- 12 opportunities in this state and the availability of those
- 13 opportunities, including for persons experiencing barriers to
- 14 employment and who are historically underrepresented in
- 15 high-growth, high-wage industries, with a particular focus on
- 16 occupations other than building and construction trades;
- 17 (B) removing barriers that impede the growth of
- 18 work-based learning opportunities in this state, including in small
- 19 and mid-size companies and in industries that have not historically
- 20 offered work-based learning opportunities;
- (C) addressing employer concerns regarding
- 22 liability for work-based learning opportunities;
- (D) improving a diverse pipeline of access to and
- 24 <u>success in work-based learning opportunities</u>, including assistance
- 25 with child care, food, and transportation;
- 26 <u>(E) aligning public and private funding for</u>
- 27 work-based learning opportunities;

1	(F) identifying data to be collected from								
2	work-based learning opportunity providers; and								
3	(G) establishing a process for the collection and								
4	maintenance of data described by Paragraph (F) and for the								
5	reporting of that data to policymakers and the public;								
6	(2) develop critical guidance for local sector or								
7	industry partnerships on how to serve as intermediaries								
8	facilitating work-based learning opportunities, including guidance								
9	regarding:								
10	(A) marketing work-based learning opportunities								
11	to community stakeholders;								
12	(B) assisting business in establishing								
13	work-based learning opportunities; and								
14	(C) providing or brokering education and								
15	training for individuals experiencing barriers to employment; and								
16	(3) identify any resources that are needed, and any								
17	current resources that could be redirected, to expand work-based								
18	learning opportunities in this state.								
19	(k) In carrying out its duties under this section, the task								
20	force shall consult with stakeholders, including young adults								
21	participating in work-based learning opportunities.								
22	(1) Not later than December 1, 2020, the task force shall								
23	submit a written report to the legislature, the commission, the								
24	coordinating board, and the agency that includes:								
25	(1) the task force's findings;								
26	(2) a summary of the stakeholder input received by the								
27	task force;

- 1 (3) recommendations for legislative or other action
- 2 <u>and proposed legislation; and</u>
- 3 (4) a statement regarding the feasibility of the task
- 4 <u>force's recommendations.</u>
- 5 (m) The task force is abolished and this section expires
- 6 <u>September 1, 2021.</u>
- 7 SECTION 2. As soon as practicable after the effective date
- 8 of this Act, the appropriate persons shall appoint the members of
- 9 the task force created by Section 133.010, Education Code, as added
- 10 by this Act.
- 11 SECTION 3. This Act takes effect September 1, 2019.
