4	SECTION 1. Section 18.001, Civil Practice and Remedies
5	Code, is amended by amending Subsections (b), (c), (d), (e), and (f)
6	and adding Subsections $(d-1)$, (g) , (h) , and (i) to read as follows:
7	(b) Unless a controverting affidavit is served as provided
8	by this section, an affidavit that the amount a person charged for a
9	service was reasonable at the time and place that the service was

16	(c) The affidavit must:

- 1 (d) The party offering the affidavit in evidence or the 2 party's attorney must serve a copy of the affidavit on each other 3 party to the case <u>not later than the earlier of:</u>
- 4 (1) 90 [at least 30] days before the date [day on which 5 evidence is first presented at] the trial commences; or
- 6 (2) the date the offering party must designate any
 7 expert witnesses under a scheduling order [of the case].
- (d-1) The party offer<u>ing</u> the affidavit in evidence or the 8 party's attorney must file notice with the clerk of the court, not 9 later than the latest date for serving a copy of the affidavit under 10 Subsection (d), that the party or the attorney served a copy of the 11 12 affidavit in accordance with this section. Except as provided by the Texas Rules of Evidence, [the records attached to] the 13 14 affidavit is [are] not required to be filed with the clerk of the 15 court before the trial commences.
- (e) A party intending to controvert a claim reflected by the affidavit must serve a copy of the counteraffidavit on each other party or the party's attorney of record by the earlier of:
- 19 (1) <u>60 days before the date the trial commences</u> [not 20 later than:
- [(A) 30 days after the day the party receives a copy of the affidavit; and
- [(B) at least 14 days before the day on which evidence is first presented at the trial of the case]; or
- 25 (2) the date the controverting party must designate
 26 expert witnesses under a scheduling order [with leave of the court,
 27 at any time before the commencement of evidence at trial].

- The counteraffidavit must give reasonable notice of the 1 basis on which the party serving it intends at trial to controvert 2 the claim reflected by the initial affidavit and must be taken 3 before a person authorized to administer oaths. 4 5 counteraffidavit must be made by a person who is qualified, by knowledge, skill, experience, training, education, or other 6 expertise, to testify in contravention of all or part of any of the 7 8 matters contained in the initial affidavit. The counteraffidavit may not be used to controvert the causation element of the cause of 9 action that is the basis for the civil action. 10
- (g) Not later than the last date for serving a copy of the counteraffidavit under Subsection (e), the party offering the counteraffidavit in evidence or the party's attorney must file written notice with the clerk of the court that the party or attorney served a copy of the counteraffidavit in accordance with this section.
- (h) If continuing services are provided after a relevant deadline under this section:
- (1) a party may supplement an affidavit served by the
 party under Subsection (b) on or before the 30th day before the date
 trial commences; and
- 22 (2) a party that served a counteraffidavit under
 23 Subsection (e) may supplement the counteraffidavit on or before the
 24 14th day before the date trial commences.
- (i) Notwithstanding Subsections (d), (d-1), (e), (g), and (h), a deadline under this section may be altered by all parties to an action by agreement or with leave of the court.

- 1 SECTION 2. The change in law made by this Act applies only
- 2 to an action commenced on or after the effective date of this Act.
- 3 An action commenced before the effective date of this Act is
- 4 governed by the law applicable to the action immediately before the
- 5 effective date of this Act, and that law is continued in effect for
- 6 that purpose.
- 7 SECTION 3. This Act takes effect September 1, 2019.
