(a) This section applies 17 only to a municipality that: 18 19 (1) operates a municipally owned water utility; and 20 (2) is a party to a strategic partnership agreement: 21 (A) with a municipal utility district; and 22 (B) under which the municipality contemplates annexing 400 or more water or wastewater connections that are not 23 24 located in the district.
