1-15 A BILL TO BE ENTITLED
1-16 AN ACT

1-17 relating to term limits for the board of hospital managers of the
1-18 Nueces County Hospital District.

1-19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 281.0221, Health and Safety Code, is
1-21 amended to read as follows:

1-22 Sec. 281.0221. TERM LIMIT. (a) A member of the board of
1-23 hospital managers of the El Paso County Hospital District may not
1-24 serve more than two consecutive three-year terms and is not
1-25 eligible for reappointment to the board until the second
1-26 anniversary of the date the member's eligibility expires under this
1-27 subsection [~~section~~].

1-28 (b) A member of the board of hospital managers of the Nueces
1-29 County Hospital District may not serve more than four full
1-30 three-year terms. The completion of the unexpired portion of a term
1-31 does not constitute service for a full term for purposes of this
1-32 subsection.

1-33 SECTION 2. (a) Section 281.0221(b), Health and Safety
1-34 Code, as added by this Act, does not affect the eligibility of a
1-35 member serving on the board of hospital managers of the Nueces
1-36 County Hospital District on the effective date of this Act to
1-37 continue to serve on the board for the remainder of the member's
1-38 term. As the terms of board members expire, the Nueces County
1-39 Commissioners Court shall appoint or reappoint members as necessary
1-40 to ensure that the composition of the board complies with Section
1-41 281.0221(b), Health and Safety Code, as added by this Act.

1-42 (b) In making an appointment or reappointment to the board
1-43 of hospital managers of the Nueces County Hospital District on or
1-44 after the effective date of this Act, the Nueces County
1-45 Commissioners Court may not appoint or reappoint a person to the
1-46 board if before the effective date of this Act the person has served
1-47 four full three-year terms on the board, not including the
1-48 unexpired portion of any term, as prescribed by Section
1-49 281.0221(b), Health and Safety Code, as added by this Act.

1-50 SECTION 3. This Act takes effect September 1, 2019.
