Section 961.004, Insurance Code, is amended to 20 read as follows: 21 Sec. 961.004. CORPORATION NOT 22 ENGAGED IN BUSINESS OF INSURANCE. A nonprofit legal services corporation [that complies 23 24 with this chapter] is not engaged in the business of insurance and  $[\tau]$ except as provided by Section 961.002(b), ] is not subject to laws 25 26 relating to insurers. The heading to Subchapter D, Chapter 961, 19 Insurance Code, is amended to read as follows: 20 SUBCHAPTER D. OFFICERS [BOARD OF DIRECTORS; PERSONNEL] 21 SECTION 8. The advance may be made in an amount and at a rate of interest agreed 10 11 to by the person and the corporation. SECTION 11. Section 961.207, Insurance Code, is amended to 12 read as follows: 13 Sec. 961.207. PARTICIPATION AGREEMENTS. A [(a) Subject to 14 15 Subsection (b), a] nonprofit legal services corporation may: (1) contract with another nonprofit legal services 16 corporation or an insurer authorized to engage in business in this 17 state for joint participation through: 18 (A) a mutualization contract agreement; or 19 20 (B) a guaranty treaty; and cede or accept a legal services obligation from 21 (2) such a corporation or insurer on all or part of a legal services 22 23 obligation. 24 [(b) Each document used for a purpose described by 25 Subsection (a) must be filed with the department and approved by the 26 department to be in accordance with the corporation's plan of 27 operation before the document takes effect.

1 [(c) To carry out the purposes of this section, the 2 commissioner may adopt rules governing an agreement with an insurer 3 under Subsection (a).]

4 SECTION 12. Section 961.254(a), Insurance Code, is amended 5 to read as follows:

6 (a) A nonprofit legal services corporation may issue a 7 contract for legal services[, as provided by rules adopted by the 8 commissioner,] providing for indemnity for costs of services of an 9 attorney who is not a contracting attorney [if the department is 10 satisfied that the corporation's plan of operation, experience, and 11 financial standing, including a proper amount of unencumbered 12 surplus, are adequate to ensure performance of the contract].

13 SECTION 13. Section 961.301, Insurance Code, is amended to 14 read as follows:

Sec. 961.301. CONTRACTS WITH ATTORNEYS. [(a)] A nonprofit legal services corporation may contract with <u>qualified</u> attorneys [as provided by this chapter] to ensure to each participant legal services performed by the attorneys under the contract for legal services between the corporation and the participant. A contracting attorney must be licensed to practice law in the jurisdiction in which legal services are to be provided.

[(b) Before issuing a contract for legal services and while the corporation continues to issue those contracts, the corporation must maintain the number of contracting attorneys that the department determines is necessary to service the participant contracts contemplated by the corporation's plan of operation.] SECTION 14. Section 961.307, Insurance Code, is amended to

2 Sec. 961.307. COMPLAINT REGARDING ATTORNEY. If <u>a nonprofit</u> 3 <u>legal services corporation</u> [the department] receives a complaint 4 concerning the performance of an attorney connected with <u>the</u> [<del>a</del> 5 <u>nonprofit legal services</u>] corporation, the <u>corporation</u> 6 [department] shall refer the complaint to:

7 (1) the supreme court of this state or a person that
8 the supreme court designates to receive attorney grievances from
9 the public, if the attorney is licensed by this state; or

10 (2) the appropriate licensing agency of another 11 jurisdiction where the attorney is licensed, if the attorney is not 12 licensed by this state.

13 SECTION 15. Section 961.402, Insurance Code, is amended to 14 read as follows:

15 Sec. 961.402. VOLUNTARY DISSOLUTION. (a) The board of 16 directors of a nonprofit legal services corporation may vote to 17 dissolve the corporation at any time[, but the corporation may not 18 be dissolved without the department's approval].

In a dissolution under this section, the officers of the 19 (b) 20 corporation shall settle all outstanding obligations to participants and otherwise dispose of the corporation's affairs. 21 22 After the officers have completed the corporation's liquidation [and a final settlement has been filed with and approved by the 23 24 department], the corporation shall be dissolved as provided by:

(1) the provisions relating to winding up and
 termination under Subchapter G, Chapter 22, Business Organizations
 Code; or

(2) if the corporation was organized [to voluntary dissolution] under the former Texas Non-Profit Corporation Act (Article 1396-1.01 et seq., Vernon's Texas Civil Statutes), the provisions relating to voluntary dissolution under that former law. SECTION 16. Section 4001.002(a), Insurance Code, is amended
