may charge a participating board a fee not to exceed the costs 1 incurred by the comptroller in providing services under this 2 subsection. The comptroller shall periodically review the fees and 3 adjust the fees as necessary to ensure recovery of costs incurred in 4 providing services to a local workforce development board under 5 this subsection. In this subsection, "local workforce development 6 7 board" means a local workforce development board created under Chapt<u>er 2308.</u> 8 9 (1) An officer or employee of a governmental entity who is engaged in official business of the governmental entity may 10 participate in the comptroller's contract for travel services. The 11 12 comptroller may charge a participating governmental entity a fee not to exceed the costs incurred by the comptroller in providing 13 services under this subsection. The comptroller shall periodically 14 15 review the fees and adjust the fees as necessary to ensure recovery of costs incurred in providing services to governmental entities 16 17 under this subsection. This subsection applies only to a governmental entity that is a party to a compact, interagency 18 19 agreement, or cooperative purchasing agreement under Section 2156.181. 20

SECTION 3. Section 2252.002, Government Code, as amended by Chapters 1127 (H.B. 1050) and 1404 (H.B. 3648), Acts of the 83rd Legislature, Regular Session, 2013, is reenacted to read as follows:

25 Sec. 2252.002. AWARD OF CONTRACT TO NONRESIDENT BIDDER. A 26 governmental entity may not award a governmental contract to a 27 nonresident bidder unless the nonresident underbids the lowest bid

(1) the amount by which a resident bidder would be 3 4 required to underbid the nonresident bidder to obtain a comparable 5 contract in the state in which the nonresident's principal place of 6 business is located; or

7 (2) the amount by which a resident bidder would be 8 required to underbid the nonresident bidder to obtain a comparable 9 contract in the state in which a majority of the manufacturing relating to the contract will be performed. 10
