## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to a child's eligibility for the Medicaid buy-in for

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 531.02444, Government Code, is amended
- 7 by amending Subsection (a) and adding Subsection (a-1) to read as
- 8 follows:
- 9 (a) The executive commissioner shall develop and implement:
- 10 (1) a Medicaid buy-in program for persons with
- 11 disabilities as authorized by the Ticket to Work and Work
- 12 Incentives Improvement Act of 1999 (Pub. L. No. 106-170) or the
- 13 Balanced Budget Act of 1997 (Pub. L. No. 105-33); and
- 14 (2) subject to Subsection (a-1) as authorized by the
- 15 Deficit Reduction Act of 2005 (Pub. L. No. 109-171), a Medicaid
- 16 buy-in program for children with disabilities that is described by
- 17 42 U.S.C. Section 1396a(cc)(1) whose family incomes do not exceed
- 18 300 percent of the applicable federal poverty level.
- 19 (a-1) The executive commissioner by rule shall increase the
- 20 maximum family income prescribed by Subsection (a)(2) for
- 21 determining eligibility for the buy-in program under that
- 22 subdivision of a child who is eligible for the medically dependent
- 23 children (MDCP) waiver program and is on the interest list for that
- 24 program to the maximum family income amount allowable, considering

- 1 available appropriations for that purpose.
- 2 SECTION 2. Subchapter B, Chapter 531, Government Code, is
- 3 amended by adding Sections 531.024441 and 531.0603 to read as
- 4 follows:
- 5 Sec. 531.024441. MEDICAID BUY-IN FOR CHILDREN PROGRAM
- 6 DISABILITY DETERMINATION ASSESSMENT. (a) The commission shall, at
- 7 the request of a child's legally authorized representative, conduct
- 8 a disability determination assessment of the child to determine the
- 9 child's eligibility for the Medicaid buy-in for children program
- 10 implemented under Section 531.02444.
- 11 (b) The commission shall directly conduct a disability
- 12 determination assessment of a child under this section and may not
- 13 contract with a managed care organization or other entity to
- 14 conduct the assessment.
- 15 Sec. 531.0603. MEDICALLY DEPENDENT CHILDREN PROGRAM
- 16 MEDICAL NECESSITY ASSESSMENT. (a) The commission shall, at the
- 17 request of the legally authorized representative of a child who is
- 18 in the first position on the medically dependent children (MDCP)
- 19 waiver program interest list, conduct a medical necessity
- 20 assessment of the child to determine the child's eligibility for
- 21 <u>that waiver program.</u>
- 22 <u>(b) The commission shall directly conduct a medical</u>
- 23 necessity assessment of a child under this section and may not
- 24 contract with a managed care organization or other entity to
- 25 conduct the assessment.
- SECTION 3. (a) Section 531.024441, Government Code, as
- 27 added by this Act, applies to a request for a disability

- 1 determination assessment to determine eligibility for the Medicaid
- 2 buy-in for children program made on or after the effective date of
- 3 this Act.
- 4 (b) Section 531.0603, Government Code, as added by this Act,
- 5 applies to a request for a medical necessity assessment to
- 6 determine eligibility for the medically dependent children (MDCP)
- 7 waiver program made on or after the effective date of this Act.
- 8 SECTION 4. If before implementing any provision of this Act
- 9 a state agency determines that a waiver or authorization from a
- 10 federal agency is necessary for implementation of that provision,
- 11 the agency affected by the provision shall request the waiver or
- 12 authorization and may delay implementing that provision until the
- 13 waiver or authorization is granted.
- 14 SECTION 5. This Act takes effect September 1, 2019.
