DELIVERY OF REFUND. (a) <u>A collector or taxing</u> 1-20 unit required by this title to deliver a refund to a person shall send the refund to the person's mailing address as listed on the 1-21 appraisal roll. (b) Notwithstanding Subsection (a), 1-22 1-23 if a person files 1-24 written request with the collector or taxing unit that a refund owed 1-25 to the person be sent to a particular address, the collector or 1-26 taxing unit shall send the refund to the address stated in the 1-27 1-28 request SECTION 2. 2-47 SECTION 7. The change in law made by this Act applies only 2-48 to a refund made on or after the effective date of this Act. A 2-49 refund made before the effective date of this Act is governed by the 2-50 law in effect on the date the refund was made, and the former law is 2-51 continued in effect for that purpose.

2-52 SECTION 8. This Act takes effect September 1, 2019.
