16	Sec. 379F.003. DEFINITIONS. In this chapter:

Sec. 379F.005. PURPOSE. A land bank created under this

- 22 <u>SUBCHAPTER B. BOARD OF DIRECTORS</u>
- Sec. 379F.051. COMPOSITION OF BOARD. The size, membership,
- 24 composition, and officers of the board of directors of a land bank,
- 25 and methods of appointment to the board, must be established by the
- 26 certificate of formation and the bylaws of the land bank.
- Sec. 379F.052. ELIGIBILITY FOR MEMBERSHIP. (a) In this

- 1 section, "public officer" means an individual who is elected to a
- 2 municipal office.
- 3 (b) A municipal employee is eligible to serve as a member of
- 4 the board, and notwithstanding any law to the contrary, a public
- 5 officer is eligible to serve as a member of the board and acceptance
- 6 of the appointment will neither terminate nor impair service in the
- 7 public office.
- 8 Sec. 379F.053. MEETINGS; ATTENDANCE. (a) The board shall
- 9 meet in regular session according to a schedule adopted by the
- 10 board.
- 11 (b) The board may meet in a special session:
- 12 (1) convened by the president of the board in
- 13 accordance with the bylaws of the board; or
- 14 (2) on written notice signed by a majority of the board
- 15 members.
- 16 (c) The presence of a majority of the board's total
- 17 membership constitutes a quorum for any regular or special session.
- 18 (d) The board shall establish rules related to the
- 19 attendance and participation of members in regular or special
- 20 meetings of the board. Rules adopted under this subsection may
- 21 provide for the removal from office of a member for failure to
- 22 comply with the rules if a majority of the remaining members of the
- 23 board vote for the removal. Removal under this subsection takes
- 24 effect the first day of the calendar month following the date of the
- 25 vote. A person removed under this subsection is ineligible for
- 26 reappointment to the board unless reappointment is confirmed
- 27 unanimously by the board.

- 1 Sec. 379F.054. BOARD ACTIONS. (a) Subject to Subsection
- 2 (b), actions of the board must be approved by the affirmative vote
- 3 of a quorum of the board.
- 4 (b) Action on the following matters requires approval by a
- 5 majority of the total membership of the board:
- 6 (1) adoption of bylaws or rules for conduct of the
- 7 business of the land bank for which the board serves;
- 8 (2) hiring or firing of any employee or contractor of
- 9 the land bank for which the board serves;
- 10 (3) incurring debt;
- 11 (4) adoption or amendment of the annual budget; and
- 12 (5) sale, lease, encumbrance, or alienation of or
- 13 improvements to real or personal property with a value of more than
- 14 \$50,000.
- 15 (c) By majority vote, the board may delegate the hiring and
- 16 firing of employees and contractors to a specific officer or
- 17 committee of the land bank for which the board serves, under terms
- 18 and to the extent specified by the board.
- 19 (d) A board member may not vote by proxy.
- 20 (e) A board member may request a recorded vote on any
- 21 resolution or action of the land bank.
- Sec. 379F.055. CONFLICT OF INTEREST. (a) A board member or
- 23 employee of a land bank may not:
- 24 (1) acquire any direct or indirect interest in real
- 25 property of the land bank, in any real property to be acquired by
- 26 the land bank, or in any real property to be acquired from the land
- 27 bank; or

- 1 (2) have any direct or indirect interest in any
- 2 contract or proposed contract for materials or services to be
- 3 furnished or used by the land bank.
- 4 (b) The provisions of the former Texas Non-Profit

- Sec. 379F.056. COMPENSATION; REIMBURSEMENT. (a) Board
- 12 members serve without compensation.
- 13 (b) The board may reimburse a member for expenses actually
- 14 incurred in the performance of duties on behalf of the land bank.
- 15 SUBCHAPTER C. CREATION, OPERATION, AND DISSOLUTION OF LAND BANK
- Sec. 379F.101. CREATION OF LAND BANK. The governing body
- 17 of a municipality may create a land bank by the adoption of an
- 18 ordinance approving the land bank's certificate of formation and
- 19 bylaws.
- Sec. 379F.102. GENERAL POWERS OF LAND BANK. (a) A land
- 21 bank has all powers necessary to carry out the purposes of this
- 22 chapter, including the power to:
- (1) adopt, amend, and repeal bylaws for the regulation
- 24 of the land bank's affairs and the conduct of the land bank's
- 25 business;
- 26 (2) sue and be sued in the land bank's own name and
- 27 plead and be interpleaded in all civil actions, including actions

- 1 created the land bank and other public and private entities for the
- 2 ownership, management, development, and disposition of real
- 3 property of the land bank;
- 4 (19) make application directly or indirectly to any
- 5 federal, state, county, or municipal government or agency or to any
- 6 other public or private source for loans, grants, guarantees, or
- 7 other financial assistance in furtherance of the land bank's public
- 8 purpose and accept and use the loans, grants, guarantees, or
- 9 financial assistance on terms prescribed by that federal, state,
- 10 county, or municipal government or agency or other source;
- 11 (20) as security for the repayment of any notes or
- 12 other obligations of the land bank, pledge, mortgage, convey,
- 13 assign, hypothecate, or otherwise encumber any property of the land
- 14 bank, including real property, fixtures, personal property,
- 15 revenue, and other funds, and execute any lease, trust indenture,
- 16 trust agreement, agreement for the sale of the land bank's notes of
- 17 other obligation, loan agreement, mortgage, security agreement, or
- 18 other agreement necessary or desirable as determined by the land
- 19 bank; and
- 20 (21) hold title to real property for purposes of
- 21 establishing contracts with public and private nonprofit community
- 22 land trusts, including long-term lease contracts.
- (b) A land bank may not:
- 24 (1) exercise the power of eminent domain; or
- 25 (2) acquire real property outside the geographical
- 26 boundaries of the municipality that created the land bank.
- Sec. 379F.103. RESOLUTION OF COMPLEX TITLE QUESTIONS. A

- 1 land bank may provide assistance and guidance to owners of real
- 2 property for which there are complex, highly divided fractional
- 3 interests in the real property because of multigenerational
- 4 intestate distributions, unknown heirs, and other interested
- 5 parties for whom accurate information cannot be ascertained.
- 6 Sec. 379F.104. INTERLOCAL CONTRACTS. (a) A land bank may
- 7 enter into an interlocal contract under Section 791.011, Government
- 8 Code, with:
- 9 <u>(1) a municipality for a program created by the</u>
- 10 municipality under Chapter 373 or 374; or
- 11 (2) a non-qualifying municipality for the purpose of
- 12 the land bank conducting land bank activities on behalf of and
- 13 within the geographical boundaries of the non-qualifying
- 14 municipality.
- (b) Notwithstanding Section 379F.102(b)(2), a land bank may
- 16 acquire real property within the geographical boundaries of a
- 17 non-qualifying municipality with which it has entered into an
- 18 agreement under Subsection (a).
- 19 Sec. 379F.105. RECORDS AND REPORTS. (a) A land bank shall
- 20 keep accurate minutes of the land bank's meetings and shall keep
- 21 accurate records and books of account that conform with generally
- 22 accepted principles of accounting and that clearly reflect the
- 23 income and expenses of the land bank and all transactions in
- 24 relation to the land bank's real property.
- 25 (b) A land bank shall maintain and make available for public
- 26 review and inspection:
- 27 (1) an inventory of all real property held by the land

- 1 bank;
- 2 (2) a copy of the sale settlement statement for each
- 3 real property sold or transferred to a third party; and
- 4 (3) a copy of the performance report filed under
- 5 Subsection (e).
- 6 (c) Not later than the 90th day after the end of the fiscal
- 7 year of the municipality that created the land bank, the land bank
- 8 shall file with the municipality an annual audited financial
- 9 statement prepared by a certified public accountant.
- 10 (d) Financial transactions of a land bank are subject to
- 11 audit by the municipality that created the land bank.
- 12 (e) For purposes of evaluating the effectiveness of a land
- 13 bank created under this chapter, a land bank shall submit an annual
- 14 performance report to the municipality that created the land bank
- 15 not later than November 1 of each year in which the land bank
- 16 acquires or sells real property in accordance with this chapter.
- Sec. 379F.106. STAFF. (a) A land bank may employ an
- 18 executive director, counsel and legal staff, technical experts, and
- 19 other agents and employees, permanent or temporary, that the land
- 20 bank may require and may determine the qualifications and set the
- 21 compensation and benefits of each of those persons.
- (b) A land bank may enter into contracts and agreements with
- 23 municipalities for staffing services to be provided to the land
- 24 bank by those municipalities or for the land bank to provide such
- 25 staffing services to those municipalities.
- Sec. 379F.107. ADVISORY COMMITTEE AND NEIGHBORHOOD
- 27 CONSULTATION. (a) A land bank shall create one or more advisory

- 1 committees to consult with and advise the land bank on:
- 2 (1) properties within the municipality served by the
- 3 land bank that are imposing the greatest harm on neighborhoods and
- 4 communities in the municipality;
- 5 (2) neighborhood priorities for new uses of those
- 6 properties; and
- 7 (3) the range of potential transferees of those
- 8 properties.
- 9 (b) As appropriate to the location of the real property of
- 10 the land bank, advisory committee membership and neighborhood
- 11 consultations shall include formal and informal
- 12 <u>neighborhood-specific</u> community associations, residents'
- 13 <u>associations</u>, faith communities, community development
- 14 corporations, and anchor institutions.
- 15 Sec. 379F.108. DISSOLUTION OF LAND BANK. (a) A land bank
- 16 may be dissolved no earlier than the 60th day after the date an
- 17 affirmative resolution to dissolve the land bank is approved by
- 18 two-thirds of the membership of the board and confirmed by
- 19 resolution of the municipality that created the land bank.
- 20 (b) Not less than 60 days before the consideration of a
- 21 resolution of dissolution by the board, the board shall:
- (1) provide to the governing body of the municipality
- 23 that created the land bank written notice of the board's intent to
- 24 vote on a resolution for dissolution of the land bank;
- 25 (2) publish the notice in a local newspaper of general
- 26 circulation; and
- 27 (3) send the notice by certified mail to the trustee of

- 1 any outstanding bonds of the land bank.
- 2 (c) On dissolution of the land bank, all real property,
- 3 personal property, and other assets and obligations of the land
- 4 bank become the assets and obligations of the municipality that
- 5 created the land bank.
- 6 SUBCHAPTER D. ACQUISITION AND DISPOSITION OF PROPERTY
- 7 Sec. 379F.151. TAX EXEMPT STATUS OF LAND BANK PROPERTY. The
- 8 real property of a land bank, including real property held by a land
- 9 bank under a long-term lease contract with a community land trust,
- 10 and the land bank's income and operations are exempt as public
- 11 property used for public purposes from all license fees, recording
- 12 fees, and all other taxes imposed by this state or by political
- 13 subdivisions of this state.
- 14 Sec. 379F.152. TITLE HELD BY LAND BANK. All real property
- 15 acquired by a land bank must be held in the name of the land bank.
- Sec. 379F.153. QUIET TITLE ACTIONS. (a) A land bank may
- 17 file an action to quiet title as to any real property in which the
- 18 land bank has an interest. For purposes of a quiet title action,
- 19 the land bank is considered to be the holder of sufficient legal and
- 20 equitable interests and possessory rights to qualify the land bank
- 21 as an adequate complainant in the action.
- (b) Before filing an action to quiet title, the land bank
- 23 shall conduct an examination of title to determine the identity of
- 24 all persons and entities possessing a claim or interest in or to the
- 25 real property. Service of the complaint to quiet title shall be
- 26 provided to the interested parties by the following methods:
- 27 (1) by first class mail to an identity and address as

- 1 reasonably ascertainable by an inspection of public records;
- 2 (2) in the case of occupied real property, by
- 3 registered or certified mail addressed to "occupant";
- 4 (3) by posting a copy of the notice on the real
- 5 property;
- 6 (4) by publication in a newspaper of general
- 7 circulation in the municipality in which the property is located;
- 8 and
- 9 (5) by another method the court may order.
- 10 (c) As part of the complaint to quiet title, a land bank
- 11 shall file an affidavit identifying all parties potentially having
- 12 an interest in the real property and the form of notice provided.
- 13 (d) A court hearing an action under this section shall:
- 14 (1) schedule a hearing on the complaint not later than
- 15 the 90th day after the date of the filing of the complaint; and
- 16 (2) issue a final judgment not later than the 120th day
- 17 after the date of the filing of the complaint for all matters on
- 18 which an answer was not filed by an interested party.
- 19 (e) A land bank may join in a single complaint to quiet title
- 20 for one or more parcels of real property.
- Sec. 379F.154. ACQUISITION OF PROPERTY GENERALLY. (a) A
- 22 land bank may acquire real property by gift, devise, transfer,
- 23 exchange, foreclosure, purchase, purchase contracts, lease
- 24 purchase agreements, installment sales contracts, land contracts,
- 25 or transfers from a municipality on terms as agreed by the land bank
- 26 and the municipality, or through any other means on terms and in a
- 27 manner the land bank considers appropriate.

- 1 (b) Notwithstanding any other law to the contrary, a
- 2 municipality served by a land bank or a non-qualifying municipality
- 3 that has entered into an interlocal contract with a land bank under
- 4 Section 379F.104 may transfer to the land bank real property of the
- 5 municipality or non-qualifying municipality on terms and according
- 6 to procedures determined by the municipality or non-qualifying
- 7 municipality.
- 8 (c) A land bank may acquire real property from this state,
- 9 the municipality served by the land bank, the county in which that
- 10 municipality is located, a governmental entity within the county,
- 11 the federal government, or an agency or department of the federal
- 12 government.
- 13 (d) A land bank shall maintain all of its real property in
- 14 accordance with the laws and ordinances of the jurisdiction in
- 15 which the real property is located.
- Sec. 379F.155. ACQUISITION OF FORECLOSED OR SEIZED
- 17 PROPERTY. (a) In this section, "taxing unit" has the meaning
- 18 assigned by Section 1.04, Tax Code.
- 19 (b) A land bank may submit a written bid to acquire real
- 20 property at a tax sale conducted in accordance with Section 34.01,
- 21 Tax Code. The bid:
- 22 (1) must be in an amount not less than the amount
- 23 calculated under Section 34.01(b), Tax Code; and
- 24 (2) may be submitted in writing in advance of the
- 25 auction or tendered in person at the auction.
- 26 (c) If the bid submitted under Subsection (b) is the highest
- 27 bid received at the sale, the land bank:

1 (1) shall: 2 (A) pay in cash the amount of the costs and 3 expenses as described by Section 33.48, Tax Code, and any penalties described by Section 33.07 or 33.08, Tax Code; or 4 5 (B) remit payment of the amounts described by Paragraph (A) to the selling officer by check or electronic funds 6 7 transfer not later than the seventh calendar day after the date of 8 the auction; and (2) is entitled to credit bid that portion of the bid 9 amount consisting of the amount of the taxes, penalties, and 10 11 interest set forth in the judgment. 12 (d) A taxing unit that is a party to a judgment of foreclosure for property sold at auction may request that the 13 14 selling officer bid off the property to the taxing unit in the 15 manner provided by Section 34.01(j), Tax Code, and, if the request is granted, the transfer to the taxing unit prevails over a bid by 16 17 the land bank if the land bank's bid is the only bid sufficient to satisfy the minimum bid described by Section 34.01(j), Tax Code. 18 19 (e) The aggregate amount of all credit bids in a calendar year shall be considered satisfied by the aggregate expenditure in 20 21 that calendar year of an amount equal to or greater than the credit 22 bid amount, which expenditures are attributable directly and indirectly to maintenance, rehabilitation, construction, 23 24 demolition, and remediation activities. As to any specific tract

of property acquired by the credit bid and transferred by a land

bank to a public entity described by Section 379F.158(a), the

credit bid shall be considered satisfied by that transfer.

- 1 (f) A land bank may submit a written request to a taxing unit 2 at any time for the commencement of tax foreclosure proceedings for delinquent taxes on real property. The request must include a 3 commitment to tender a bid in the amount specified under Subsection 4 5 (b). On receipt of the written request, the taxing unit, or the governmental office acting on behalf of the taxing unit, shall 6 7 commence enforcement proceedings in accordance with Section 33.41, 8 Tax Code.
- 9 (g) If there is no private third party bid in an amount more
 10 than the bid of the land bank, the real property must be sold to the
 11 land bank.
- 12 (h) A sale to a land bank under this section is not a sale to
 13 a taxing unit under Section 34.01(j) or (p) or 34.21, Tax Code.
- (i) A land bank may bid an amount higher than the amount

 calculated under Section 34.01(b), Tax Code, and if that higher bid

 amount is the highest successful bid, the land bank shall pay the

 full amount of the bid in cash.
- (j) The deed to a land bank vests good and perfect title in 18 19 the land bank to the right, title, and interest owned by the defendants included in the foreclosure judgment, including the 20 defendants' right to the use and possession of the property, 21 subject only to the defendants' right of redemption, the terms of a 22 recorded restrictive covenant running with the land that was 23 24 recorded before January 1 of the year in which the tax lien on the property arose, a recorded lien that arose under that restrictive 25 26 covenant that was not extinguished by the judgment foreclosing the 27 tax lien, and each easement of record as of the date of the sale that

- 1 was recorded before January 1 of the year the tax lien arose.
- 2 (k) A sale of real property to a land bank under this
- 3 section:
- 4 (1) extinguishes each lien securing payment of the
- 5 delinquent taxes, penalties, and interest against the property and
- 6 included in the judgment; and
- 7 (2) does not affect the personal liability of any
- 8 person for those taxes, penalties, and interest included in the
- 9 judgment that are not satisfied from the proceeds of the sale.
- 10 (1) A municipality, and any taxing unit levying property
- 11 taxes within the geographical jurisdiction of the municipality, may
- 12 convey tax foreclosed real property owned by the municipality or
- 13 the taxing unit to the land bank on terms and for an amount of
- 14 consideration determined by the transferor and the land bank.
- 15 Sec. 379F.156. REDEMPTION BY OWNER OF FORECLOSED PROPERTY.
- 16 (a) The owner of real property sold to a land bank under Section
- 17 379F.155 may redeem the property in the manner prescribed for
- 18 owners of real property sold at a tax sale to a purchaser other than

- 20 (b) The price to be paid by the owner of real property sold
- 21 to a land bank under this section to redeem the property shall be in

- 12 due in accordance with the judgment of foreclosure.
- 13 Sec. 379F.157. DISPOSITION OF PROPERTY GENERALLY. (a) A
- 14 land bank may convey, exchange, sell, transfer, lease as lessor,
- 15 grant, release and demise, pledge, or hypothecate any interest in,
- 16 on, or to real property of the land bank.
- 17 (b) A municipality may, in the ordinance creating a land
- 18 bank, require that a particular form of disposition of real
- 19 property of the land bank, or any disposition of real property
- 20 located within a specified jurisdiction of the municipality, be

- 8 Sec. 379F.158. DISPOSITION OF PROPERTY FOR FLOOD CONTROL
- 9 AND STORM WATER DRAINAGE AND PLANNING. (a) A land bank may convey
- 10 to a public entity such as a flood control district or a municipal
- 11 parks and recreation department real property held by the land
- 12 bank:
- 13 (1) for which the highest and best use is flood control
- 14 or storm water retention or drainage; and
- 15 (2) that, as a result of housing and building code

- Sec. 379F.201. GENERAL FINANCING. (a) A land bank may
- 3 receive funding through grants and loans from the municipality that
- 4 created the land bank, other municipalities, this state, the
- 5 federal government, and other public or private sources.
- 6 (b) A land bank may receive and retain payments for services
- 7 rendered, for rents and leasehold payments received, for

Not more than 75 percent of the real property taxes the 5 municipality that created the land bank collected on real property, excluding any school district or county ad valorem tax, conveyed by 6 7 a land bank under the laws of this state shall be remitted to the 8 land bank. The real property taxes of any other taxing unit, as to real property of the land bank, may also be allocated to the land 9 10 bank in a similar manner under an interlocal agreement between the other taxing unit and the land bank. The specific percentage of 11 those taxes to be remitted shall be established by ordinance, 12 resolution, or interlocal cooperation agreement of the land bank. 13 14 The allocation of property tax revenue shall begin with the first 15 taxable year following the date of conveyance and shall continue for a period of five years. The funds shall be remitted to the land 16 17 bank in accordance with the administrative procedures established by the assessor-collector of the county in which the land bank is 18 19 located. The allocation of property tax revenue may not occur if those taxes have been previously allocated to a tax increment 20 reinvestment zone, or to secure a debt of the municipality or other 21 22 taxing unit, unless the municipality or other taxing unit enters into an agreement with the land bank for the remittance of those 23 24 funds to the land bank. Any property tax revenue allocated to the land bank under this subsection shall be excluded from the 25 26 calculation of ad valorem tax revenue under the municipality's 27 charter.

- 1 Sec. 379F.205. ISSUANCE OF BONDS. (a) A land bank may
- 2 issue bonds for the land bank's purposes. The principal and
- 3 interest of bonds issued under this section are payable from the
- 4 land bank's general revenue. Any bonds issued under this section
- 5 may be secured by a pledge of any revenue, including grants or
- 6 contributions from this state, the federal government, or any
- 7 agency or instrumentality of this state or the federal government,
- 8 or by a mortgage of any real property of the land bank.

- 27 the proceeds of the refunding bonds, may not constitute an

- (j) Bonds issued by a land bank shall be issued, sold, and
- 17 delivered in accordance with the terms and provisions of a

- 19 the bonds in a manner, either at public or at private sale, and for a
- 20 price as the board determines to be in the best interests of the
- 21 land bank. The resolution issuing bonds shall be published in a
- 22 newspaper of general circulation within the jurisdiction of the
- 23 land bank.
- 24 (k) A board member or a person executing the bonds is not
- 25 liable personally on any bonds by reason of the issuance of the
- 26 bonds. The bonds or other obligations of the land bank are not a
